If the Treasurer receives compensation other than the amount received by the other board members, CVF's bylaws require that the Treasurer compensation be annually reviewed by the Personnel & Board Compensation Committee. The Treasurer's contract states that the annual review is to be completed by June. The Treasurer submits a report of activities and approximate hours for the past year to the Committee. The Committee then reviews the report and develops a recommendation regarding the Treasurer's compensation to the Board. The Board will vote on the Committee's recommendation.
