Process for Approving Raises

All salaries at The Haven were determined by using a salary comparison amongst similar positions, educational requirements, and job responsibilities. The comparisons used were the Louisiana Association of Non-profits Salary and Benefit Survey and the Louisiana Foundation for Sexual and Domestic Violence Salary and Benefit Survey.

The Board of Directors of The Haven sets a salary range based on its review of comparable data for each job. The range is placed on the job description. The Executive Director is authorized to provide compensation for the employee within the range. The Executive Director at her discretion and after each annual review can recommend raises for each position as long as the raise is within the salary range listed on each job description. The finance committee reviews the recommended increases and approves for inclusion in the annual budget. The annual budget is then presented to the full governing body for approval.

The Executive Director's salary range is determined through the same process as other positions. The Executive Committee of the Board of Directors annually evaluates the Executive Director and makes recommendations to the finance committee for any increase in the level of compensation of the Executive Director. The full governing body approves the level of compensation when approving the annual budget.

There is no compensation provided to Board Members or Officers of the Board.
