COVERING KIDS AND FAMILIES INCOME WAS PRIMARILY FUNDED BY LOUISIANA DEPARTMENT OF HEALTH AND HOSPITALS-MEDICAID. THIS PROGRAM WAS DEVELOPED AS AN EFFORT TO INCREASE THE ENROLLMENT IN THE LACHIP AND LAMOM PROGRAM WHICH PROVIDED HEALTH INSURANCE TO CHILDREN IN FAMILIES WITH INCOMES OF UP TO 250% OF POVERTY LEVEL.
