Our mission, as a volunteer organization, is to develop and support education-focused projects and programs focused on poor children and their families of Mexican heritage

28 We are committed to providing unconditional love and support, helping poor Mexican children to improve their lives, and moving them toward a better future and self-sufficiency. We serve as a bridge that connect those we serve with volunteers and donors who want the opportunity to contribute, grow and change. Our efforts are focused on three primary programs in southern Mexico: Ecoser Learning Center in Tuxtula, Chiapas; The Ecoser learning center is located in Tuxtula, Chiapas. There were up to 21 students enrolled in the program during the year 2010/2011. All of these students were enrolled in and attending college. The nonprofit organization, Friends Of Pimpollo, financially supported this program with grants of \$2,600 monthly. The funding provides board and room, tuitions, fees, books, clothing and incidentals. Occasionally when extra funds are available, we are able to purchase other items, such as much-needed new computers. This program is led by a devoted couple, Chelo and Felix Velazquez Castillo, who take these young people into their own home and act as parents and counselors for them as they attempt the journey of higher education. Most of these students come from the Pimpollo children's home and some come from the surrounding remote Hill Villages in the mountains of Chiapas. Through this program, we have had four students graduate from college. Three more will graduate in 2012. Outside of the ECOSER program, Friends of Pimpollo supports sixteen other students in Oaxaca who are attending school (from elementary school students to college). Pimpollo Home for Children in Juchitan, OaxaSince the formation of Friends of Pimpollo in 2001, we have helped to support the Pimpollo Home for Children in Juchitan, Oaxaca, Mexico. Our Child Sponsorship Program supplements the monthly food, education and medical expense budgets for very deserving children without parents. There are currently forty-four children living at the Pimpollo Home in Juchitan. The home for the disabled, which we helped to finance, is now up and running. Nine Pimpollo children with special needs have been moved to that location. A local woman lives on site and sees to their needs. Friends of Pimpollo sponsorships of the special needs children are now helping to support them in their new home. Friends of Pimpollo has been providing \$4,500 per month to support both homes. Vicente Guerrero Community Center in Juchitan, OaxacaVicente Guerrero is an impoverished community on the outskirts of OaxacaCity, where the city dump is located. Friends of Pimpollo provides financial support to the Vicente Community through a grant of \$2,200 per month to the organization "Fundacion de Apoyo para Educacion" (Foundation for the Support for Education) to cover the costs of running a local community center that offers a range of educational activities for children and adults, including computer classes, English classes, adult education programs, and mobile libraries. Additional funds are also sent to complete specific school construction projects and needs at six Vicente Guerrero schools. The Vicente Guerrero project is lead by Director Bonifacio Luis Hernandez, whose salary is covered in the grant.
