THIS PAST YEAR OUR EARLY CHILDHOOD EDUCATION PROGRAMS AT OKC EDUCARE, TONY REYES, EMERSON AND HOME-BASED PROGRAMS SERVED 897 CLIENTS (387 CHILDREN BIRTH TO AGE 5 AND THEIR 510 FAMILY MEMBERS).

INDEPENDENT EVALUATIONS OF CHILDREN AT OKC EDUCARE, WHERE MOST OF EARLY CHILDHOOD SERVICES ARE PROVIDED, REFLECT SIGNIFICANT GAINS IN SELF-HELP, GROSS AND FINE MOTOR SKILLS, COGNITION, AND SOCIAL EMOTIONAL SKILLS FOR 72% OF CHILDREN BIRTH TO AGE 3 AND FOR 77% OF CHILDREN AGES 3-5. OUR ITTERS SCORE (AN ENVIRONMENTAL RATING IN BIRTH TO AGE 3 CLASSROOMS) INCREASED FROM 5.1 TO 6.2. THIS SAME RATING FOR 4 AND 5 YEAR OLD CLASSROOMS IS THE ECERS. OUR SCORES ON THIS SCALE INCREASED FROM 5.38 TO 5.97. BOTH ARE RATED ON A

THE CAREGIVER FUNDAMENTALS PROGRAM SET A GOAL OF PROVIDING 6,300 UNITS OF CAREGIVER EDUCATION, COUNSELING, RESPITE SERVICES AND SCHOOL SUPPLIES TO 1300 CLIENTS AND ULTIMATELY PROVIDED 4,866 UNITS OF SERVICE TO 1,112 CLIENTS. THE THREE MOST REQUESTED SERVICES WERE ACCESS TO SERVICE, RESPITE CARE AND SCHOOL SUPPLIES REQUESTED BY LOW INCOME GRANDPARENTS RAISING THEIR GRANDCHILDREN. THESE SERVICES MADE THE FAMILY CARE GIVING JOURNEY MORE MANAGEABLE AND EXTENDED THE LENGTH OF TIME LOVED ONES WERE ABLE TO CONTINUE LIVING IN THEIR OWN HOME.

OUR INITIAL GOAL WAS TO PROVIDE 5,472 DAYS OF CARE TO 300 CHILDREN IN FY11. WE REVISED THE GOAL IN RESPONSE TO ACTION TAKEN BY DHS TO REDUCE THE NUMBER OF SUCH CHILDREN PLACED IN STATE CUSTODY.
