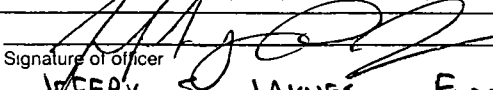

This program provides essential social services for individuals and families at risk of homelessness by allowing them to maintain their current residence The program targets the working poor to ensure they will not join the ever-growing homeless population Restore Hope Ministries helped 3,885 persons with direct financial aid with the goal of preventing homelessness As an expansion of the Homelessness Prevention program, Restore Hope Ministries worked with INCOG and the Mental Health Association of Tulsa to assist an additional 258 individuals who were at imminent risk of becoming homeless
