As a result of hosting this meeting, there are at least 15 additional ministries who are in the process of ordering Prayer Stations so that they too can make prayer available in public places. Prayer Stations are just one of the great prayer connections KSBJ provides. Because we believe so strongly in the power of prayer, we have made it a priority to have prayer volunteers available all day, every day. KSBJ continues to partner with Need Him Ministries and Global Media Outreach to ensure there are always volunteers available to pray with listeners.
