THE NURSE ONCOLOGY EDUCATION PROGRAM (NOEP) HAS BEEN IN EXISTENCE SINCE 1987 TO PROVIDE EVIDENCE-BASED CONTINUING EDUCATION TO NURSES IN ALL FIELDS OF PRACTICE ON CANCER PREVENTION, DETECTION, TREATMENT, AND SURVIVORSHIP. THE MAJORITY OF NOEP'S FUNDING COMES FROM THE CANCER PREVENTION AND RESEARCH INSTITUTE OF TEXAS (CPRIT), A STATE AGENCY FORMERLY KNOWN AS THE TEXAS CANCER COUNCIL. ADDITIONAL FUNDING IS RECEIVED FROM THE LANCE ARMSTRONG FOUNDATION (LAF), A CANCER EDUCATION AND ADVOCACY FOUNDATION, TO COMPLETE SMALL PROJECTS THAT FIT WITHIN THEIR AGENDA. NOEP HAS A SMALL CONTRACT WITH THE DEPARTMENT OF STATE HEALTH SERVICES COMPREHENSIVE CANCER CONTROL PROGRAM.
