Now in its forty-ninth year, the orchestra is comprised of a core of sixty professional musicians from throughout the DFW area under the leadership of Anshel Brusilow, Music Director and Conductor.
Founded in 1961, the Richardson Symphony has grown with the northern part of the DFW metroplex to become the premiere orchestra in the region. Richardson Symphony performs a critically-acclaimed season of six subscription series performances and is the resident symphony of the Charles W. Eisemann Center for the Performing Arts. RSO offers a variety of classical and pops concerts each season programmed to appeal to the varied audiences.

The Richardson Symphony further seeks to educate current and future audiences for a lifelong involvement with symphonic music by providing high quality, comprehensive music education, including educational children's concerts, performance opportunities for young talented musicians, through the development of partnerships and collaborations with musicians, educational institutions, community organizations, and individuals.
The Lennox International Young Artists Competition for Piano and Strings annually draws young performers from across the nation. In addition, the orchestra is actively involved in elementary education programs (Symphony days) in the Richardson Independent School District and in programs benefiting students at local and surrounding universities and colleges.
