	See Schedule OBaylor University Medical Center (BUMC), a faith-based, non-profit 1,020-bed acute care hospital, is the flagship hospital of Baylor Health Care System (BHCS), a nationally acclaimed network of acute care hospitals and related health care entities providing quality patient care, medical education, medical research and community services to the North Texas region BUMC is a major patient care, research and medical education center of the Southwest and serves local, national and international patients. BUMC provides inpatient and outpatient medical services to treat individuals with diseases, illnesses and injuries of varying complexities. Services include providing patients with innovative methods of prevention, diagnosis, treatment, education and support consistent with a quality teaching and research hospital with multidisciplinary interaction among physicians, and include comprehensive care for all stages of illness through all stages of life. Some of these clinical services are provided despite a financial loss to BUMC. BUMC operates an emergency department and level 1 trauma center encompassing 78,000 square feet with 87 patient rooms, including four major trauma care beds. This level 1 trauma center is one of only two providing adult trauma services in Dallas County, with more than 100,000 patients during the fiscal year ended June 30, 2011. South Dallas residents are 30 percent more likely to be admitted to a hospital due to diabetes or a diabetes-related condition than other city of Dallas residents. In an effort to improve these conditions, the Diabetes Health and Wellness Institute at Juanita. J. Craft Recreation Center (DHWI) was opened during FY 2010 as an affiliate of BHCS. BUMC supported the Institute through community wellness initiatives designed to increase access to care and extend the wellness and quality of life for South Dallas Frazier neighborhood residents with events such as the Dr. Oz Know Your Five health. 	See Schedule OBaylor University Medical Center (BUMC) provided medical residency programs for the training of future physicians, nurses and other health professionals in an effort to increase the supply of health care professionals nationwide. During the year, BUMC served 220 medical residency students. Assisting with the preparation of future nurses at entry and advanced levels of nursing is critical to establishing a workforce of qualified nurses. Through their work with six Dallas County schools of nursing, Baylor strengthened and increased the number of affiliations with schools of nursing. During the year, BUMC invested in training 634 undergraduate nurses. Total unreimbursed cost of these programs was \$35,077,485.

Notes to Combined Financial Statements

For the Years Ended June 30, 2011 and 2010

1. ORGANIZATION

Baylor Health Care System (BHCS) is a Texas nonprofit corporation exempt from federal income taxation under Section 501(c)(3) of the Internal Revenue Code The combined financial statements include the accounts of BHCS, Baylor University Medical Center (the Medical Center), Baylor Health Care System Foundation (Foundation), All Saints Health Foundation, nine community and specialty medical centers located throughout the Dallas and Fort Worth metroplex, two wholly owned insurance subsidiaries and other related entities (collectively referred to as the "System") Investments in certain related entities with 50 0% or less ownership are accounted for using the equity method Investments in certain related entities with greater than 50 0% ownership or where the System exercises board control are included in the accompanying combined financial statements with related noncontrolling interests or minority interests reported in the combined financial statements. All significant intercompany accounts and transactions among entities included in the combined financial statements have been eliminated

The following summarizes significant changes in the System in 2011 and 2010

Irving Healthcare Foundation

Effective March 17, 2010, the Irving Healthcare Foundation (IHF) was reorganized by its Board of Directors whereby Baylor Medical Center at Irving (Irving), an affiliate of the System, is the new sole member of IHF As a result, IHF's balances and transactions are reflected in the combined financial statements in 2011 and 2010

Baylor Medical Center at Carrollton

BRMCG Holdings, LLC is wholly owned by Baylor Regional Medical Center at Grapevine (BRMCG), an affiliate of BHCS Effective May 1, 2011 BRMCG Holdings merged with Trinity MC, LLC (TMC), with TMC becoming the sole surviving entity in the merger. The membership interest in BRMCG Holdings held by BRMCG immediately prior to the effective date of the merger was cancelled and converted into 100% of the ownership interest in TMC Each of the minority member units in TMC outstanding immediately prior to the effective date of the merger were purchased by BRMCG and cancelled. The ownership interests in TMC were 71.0% and 29.0% by BRMCG Holdings, LLC and by the Physician Members, respectively, as of June 30, 2010.

Texas Health Ventures Group, LLC (THVG)

The Medical Center has a majority ownership of 50 1% in THVG with USP North Texas, Inc (USP), a Texas corporation and subsidiary of United Surgical Partners, Inc (USPI) holding the remaining 49 9% THVG had net patient care revenue included in the BHCS combined financial statements of approximately \$578,824,000 and \$478,973,000 in 2011 and 2010, respectively

BIR JV, LLP

Effective April 1, 2011 BIR JV, LLP (BIR JV), a Texas limited liability partnership, was formed between Baylor Institute for Rehabilitation at Gaston Hospital (BIR), an affiliate of the System, and Select Physical Therapy Texas Limited Partnership (Select), a Delaware limited partnership, to provide rehabilitation services to the North Texas Region BIR contributed a freestanding inpatient rehabilitation hospital and certain outpatient clinics located throughout the North Texas Region valued at \$28,180,000 in exchange for a 699 units in BIR JV Select contributed an inpatient rehabilitation hospital and certain outpatient clinics located throughout the North Texas

Region valued at \$12,145,000 in exchange 301 units in BIR JV Pursuant to the terms of the agreement, Select purchased 189 units in BIR JV from BIR for \$7,614,250 resulting in BIR holding 510 units or a 51% ownership interest and Select holding 490 units or a 49% ownership interest in BIR JV Goodwill recorded as part of this transaction totaled \$17,891,000

2. SIGNIFICANT ACCOUNTING POLICIES

The accompanying financial statements of BHCS have been prepared in conformity with accounting principles generally accepted in the United States The following is a summary of the significant accounting and reporting policies used in preparing the financial statements

Adoption of New Accounting Pronouncements

In June 2009, the Financial Accounting Standards Board (FASB) issued Statement No 168, "The FASB Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (a replacement of FASB Statement No. 162," or SFAS 168, that establishes the FASB Accounting Standards Codification (Codification) as the single source of authoritative US GAAP. The Codification does not create any new GAAP standards but incorporates existing accounting and reporting standards into a new topical structure. The new guidance was effective for the System beginning in the three months ended September 30, 2009, and a new referencing system is now used to identify authoritative accounting standards, replacing the existing references to SFAS, EITF, FSP, etc. Existing standards are designated by their "Accounting Standards Codification (ASC)" topical reference and new standards will be designated as "Accounting Standards Updates (ASU)," with a year and assigned sequence number

In January 2010, FASB issued ASU 2010-07, "Not-for-Profit Entities: Mergers and Acquisitions," including an amendment to ASC 350, "Goodwill and Other Intangible Assets," which is effective for fiscal years, and interim periods within those fiscal years, beginning on or after December 15, 2009. This Statement provides guidance on accounting for a combination of not-for-profit entities, which is a transaction or other event that results in a not-for-profit entity initially recognizing another not-for-profit entity, a business, or a nonprofit activity in its financial statements. This Statement applies to a combination that meets the definition of either a merger of not-for-profit entities or an acquisition by a not-for-profit entity.

As prescribed by ASC 350, goodwill is assigned to reporting units and is subject to annual impairment testing. The System ceased to amortize goodwill recorded on its not-for-profit entities on July 1, 2010 as a result of the issuance of ASU 2010-07. The System completed the transitional impairment test in accordance with ASC 958, and no indication of an impairment existed. The goodwill is subject to an annual impairment test as of June 30 each year, the System's fiscal year end. The impact of this new standard will be affected by the level of transactions and acquisitions entered into by the System.

Notes to Combined Financial Statements - continued

In December 2007, the FASB issued ASC 810, "Consolidation," which is effective for fiscal years, and interim periods within those fiscal years, beginning on or after December 15, 2008 ASC 810 requires a company to clearly identify and present ownership interests in subsidiaries held by parties other than the company in the financial statements within the equity section but separate from the company's equity It also requires the amounts of consolidated net income attributable to the parent and to the non-controlling interest to be clearly identified and presented on the face of the consolidated statement of operations, changes in ownership interest to be accounted for as equity transactions, and when a subsidiary is deconsolidated, any retained noncontrolling equity investment in the former subsidiary and the gain or loss on the deconsolidation of the subsidiary must be measured at fair value The System adopted the provisions of ASC 810 effective July 1, 2009 for its entities that are controlled by for-profit parents For the remaining for-profit entities controlled by nonprofit parents, ASC 810 became effective July 1, 2010 when ASC 958 was adopted The adoption of ASC 958 resulted in an adjustment to unrestricted net assets of approximately \$97,238,000 as of July 1, 2010 System now reflects noncontrolling interests in subsidiaries as either noncontrolling interests redeemable in the mezzanine section of the combined balance sheets, or noncontrolling interests nonredeemable in net assets in the combined balance sheets, according to ASC 810 implementation of ASC 810 also results in the cash flow impact of certain transactions with noncontrolling interests being classified within financing activities, consistent with the view that under ASC 810 transactions between the System (or its subsidiaries) and noncontrolling interests are considered to be equity transactions. Upon the occurrence of various fundamental regulatory changes, the System could be obligated, under the terms of its investees' partnership and operating agreements, to purchase some or all of the noncontrolling interests related to the System's consolidated for-profit subsidiaries. These repurchase requirements are limited to the portions of the System's consolidated for-profit subsidiaries that are owned by physicians and would be triggered by regulatory changes making the existing ownership structure illegal. While the System is not aware of events that would make the occurrence of such a change probable, regulatory changes are outside the System's control Accordingly, the noncontrolling interests subject to these repurchase provisions have been classified in the mezzanine, outside of net assets, on the System's combined balance sheets

In January 2010, the FASB issued ASU 2010-06, "Fair Value Measurements and Disclosure (Topic 820): Improving Disclosures about Fair Value Measurements," or ASU 2010-06 This ASU amends the disclosure requirements of ASC 820 related to recurring and non-recurring fair value measurements. The ASU requires new disclosures on the transfers of assets and liabilities between Level 1 (quoted prices in active market for identical assets or liabilities) and Level 2 (significant other observable inputs) of the fair value measurement hierarchy, including the reasons and the timing of the transfers Additionally, the ASU requires a roll forward of activities on purchases, sales, issuance, and settlements of the assets and liabilities measured using significant unobservable inputs (Level 3 fair value measurements). The ASU became effective for the System on July 1, 2010, except for the disclosure provisions on the roll forward activities for the Level 3 fair value measurements, which will become effective for the System for fiscal years, and interim periods within those fiscal years, beginning July 1, 2011. The adoption of the disclosure provisions of transfers between Level 1 and Level 2 assets and liabilities has no impact on the results of operations or financial position as of June 30, 2011.

In August 2010, the FASB issued ASU 2010-23, "Measuring Charity Care for Disclosure (Topic 954): Health Care Entities." This ASU amends the disclosure requirements of ASC 954 related to the measurement basis used in the disclosure of charity care. The ASU requires that cost be identified as the direct and indirect costs of providing charity care. This ASU results in various techniques being used to identify charity care costs and requires disclosure of the method applied. The System applied the updated provisions of ASU 2010-23 in 2011.

Other Accounting Pronouncements

In August 2010, the Financial Accounting Standards Board issued ASU 2010-24, "Presentation of Insurance Claims and Related Insurance Recoveries (Topic 954): Health Care Entities." This ASU amends Topic 954 to be consistent with the guidance on netting receivables and payables under ASC 210-20, "Balance Sheet – Offsetting" The ASU clarifies that a health care entity should not net insurance recoveries against a related claim liability. In addition, the amount of the claim liability should be determined without consideration of insurance recoveries. The System has not evaluated all of the updated provisions, which are effective for fiscal years, and interim periods within those fiscal years, beginning after December 15, 2010

Notes to Combined Financial Statements - continued

In July 2011, The FASB issued ASU 2011-07, "Health Care Entities (Topic 954): Presentation and Disclosure of Patient Service Revenue, Provision for Bad Debts, and the Allowance for Doubtful Accounts for Certain Health Care Entities." This ASU requires certain health care entities to change the presentation of their statement of operations by reclassifying the provision for bad debts associated with patient service revenue from an operating expense to a deduction from patient service revenue (net of contractual allowances and discounts) Additionally, those health care entities are required to provide enhanced disclosure about their policies for recognizing revenue and assessing bad debts. The amendments also require disclosures of patient service revenue (net of contractual allowances and discounts) as well as qualitative and quantitative information about changes in the allowance for doubtful accounts For nonpublic entities, the amendments are effective for the first annual period ending after December 15, 2012, and interim and annual periods thereafter, with early adoption permitted The amendments to the presentation of the provision for bad debts related to patient service revenue in the statement of operations should be applied retrospectively to all prior periods presented. The disclosures required by the amendments in this Update should be provided for the period of adoption and subsequent reporting periods The System has not yet completed the process of evaluating the impact this ASU will have on its financial statements

In September 2011, the FASB issued ASU 2011-08, "Intangibles - Goodwill and Other (Topic 350): Testing Goodwill for Impairment." This ASU provides an entity the option to first assess qualitative factors to determine whether the existence of events or circumstances leads to the determination that it is more likely than not that the fair value of a reporting unit is less than its carrying amount. If, after assessing the totality of events and circumstances, an entity determines that it is not more likely than not that the fair value of the reporting unit is less than its carrying amount, then performing the two-step impairment test is unnecessary. This ASU is effective for annual and interim goodwill impairment tests performed for fiscal years beginning after December 15, 2011 with early application permitted in an entity's financial statements that have not yet been issued. The System has not yet completed the process of evaluating the impact this ASU will have on its financial statements

Cash and Cash Equivalents

Cash equivalents are defined as investments which have original maturities of three months or less. Cash equivalents consist primarily of securities issued by the United States government or its agencies, certificates of deposit, commercial paper and dollar denominated foreign issuer investments.

THVG Funds Due From United Surgical Partners, Inc.

THVG participates in a shared services accounts payable program with USPI, wherein USPI has custody of substantially all of THVG's excess cash, paying THVG and its facilities interest income on the net balance at prevailing market rates. Amounts held by USPI on behalf of THVG totaled \$46,538,000 and \$43,709,000 at June 30, 2011 and 2010, respectively. The funds due from USPI are available on demand. The interest income amounted to \$235,000 and \$338,000 for the years ended June 30, 2011 and 2010, respectively.

Investments

The System has designated all of its investments as trading securities except for those investments held at the Baptist Foundation of Texas (BFT) for the benefit of the Foundation For all trading investments, the interest and dividends, realized and unrealized gains (losses) are included in gains (losses) on investments, net, in the accompanying combined statements of operations and changes in net assets. For other than trading investments, interest and dividends and realized gains (losses) are included in gains (loss) on investments, net, unless restricted by donor Unrealized gains (losses) on other than trading investments are included in other changes in unrestricted net assets, unless restricted by donor

Receivables from government-related programs (i e, Medicare and Medicaid) represent the only concentrated group of payors for the System's receivables, and management does not believe that there is any unusual level of collectability risks associated with these government programs Commercial and managed care receivables consist of receivables from various payors involved in diverse activities and subject to differing economic conditions and do not represent any concentrated collectability risks to the System

The System maintains allowances for uncollectible accounts for estimated losses resulting from a payor's inability to make payments on accounts. The System assesses the reasonableness of the allowance account based on historical write-offs, cash collections, and the aging of the accounts. Accounts are written off when collection efforts have been exhausted. Management continually monitors and adjusts its allowances associated with its receivables.

Securities Lending Program

The System participates in securities lending transactions with The Northern Trust Company, investment custodian, whereby a portion of its investments is loaned to selected established brokerage firms in return for cash and securities from the brokers as collateral for the investments loaned, usually on a short-term basis of 30 to 60 days Collateral provided by brokers is maintained at levels approximating 102 0% of the fair value of the securities on loan and is adjusted for daily market fluctuations. Cash collateral received in connection with these loans is invested in a short-term pooled fund maintained by the lending agent. As of June 30, 2011 and 2010, the fair value of securities on loan was \$107,447,000 and \$117,833,000, respectively, and is included in long-term investments in the accompanying combined balance sheets. The cash collateral held for loaned securities was \$109,626,000 and \$120,712,000 as of June 30, 2011 and 2010, respectively, included in invested collateral - securities lending program. The System's obligation to repay the collateral upon settlement of the lending transactions is reported as a payable under securities lending program in the accompanying combined balance sheets

On July 30, 2004, the System sold twenty medical office buildings to Healthcare Realty Trust Properties of Texas, Ltd (HRT) for approximately \$133,000,000 of cash. The buildings sold had a net book value of approximately \$61,200,000. The transaction included several ground leases with terms of fifty-five years and an estimated economic value of approximately \$12,400,000. The System has a remaining deferred gain recorded as part of this transaction, which is being recognized over the related capital and operating lease periods. The remaining deferred gain was \$9,084,000 and \$9,357,000 as of June 30, 2011 and 2010, respectively, of which \$273,000 is included in current liabilities and \$8,811,000 and \$9,084,000, respectively, is included in other long-term liabilities in the accompanying combined balance sheets. The System amortized approximately \$273,000 of the remaining deferred gain in both years ended June 30, 2011 and 2010.

Property and equipment financed under capital leases totaled approximately \$429,216,000 and \$457,651,000 at June 30, 2011 and 2010, respectively, and related accumulated amortization was approximately \$62,348,000 and \$45,450,000 at June 30, 2011 and 2010, respectively Amortization expense is included in depreciation and amortization expense in the accompanying combined statements of operations

During fiscal year 2010, the System conducted a comprehensive fixed asset physical inventory count for all entities During fiscal year 2011, the System implemented a new policy to perform the physical inventory counts on a three year rotation. The counts resulted in approximately \$153,000 and \$12,444,000 of disposals recorded in nonoperating gains (losses) in the accompanying combined statements of operations for fiscal year 2011 and 2010, respectively

Depreciation and amortization expense is calculated using the straight-line method over the estimated useful lives of the property and equipment or the lease term, whichever is less Routine maintenance and repairs are charged to expense as incurred Expenditures that increase capacities or extend useful lives are capitalized

Goodwill and Intangible Assets

Goodwill and intangible assets recorded in connection with acquisitions completed by the System are accounted for under ASC 350, "Intangibles - Goodwill and Other." Goodwill consists of costs in excess of tangible and intangible net assets acquired Intangible assets consist of management service contract rights and other intangibles Most of these intangible assets have indefinite lives Goodwill and indefinite lived intangible assets are tested for impairment annually or more frequently if changing circumstances warrant For the purposes of these analyses, the System's reviews the cost, income, and market approaches to fair value in accordance with ASC 820 The System's estimates of fair value are based on a combination of the income approach, which estimates the fair value of the Company based on its future discounted cash flows, and the market approach, which estimates the fair value of the Company based on comparable market prices, and cost approach No impairments were identified for the years ended June 30, 2011 and 2010 Prior to July 1, 2010, the System amortized goodwill over periods estimated to be benefited, with the period not to exceed forty years Beginning July 1, 2010, ASC 958 required the System to cease amortization of goodwill and test for impairment annually The System performed an initial impairment test as of July 1, 2010 in accordance with the guidance No impairments were identified as of this date. This guidance made effective ASC 350 for nonprofit subsidiaries, which previously only applied to the System's for-profit subsidiaries The System amortizes intangible assets with definite useful lives over their respective useful lives to the estimated residual values and reviews them for impairment in the same manner as property and equipment discussed below

Impairment of Long-Lived Assets

Long-lived assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount of an asset, or related groups of assets, may not be recoverable from estimated future cash flows. In the event of impairment, measurement of the amount of impairment may be based on appraisal, fair values of similar assets or estimates of future discounted cash flows resulting from the use and ultimate disposition of the asset. No impairment was identified in 2011 or 2010.

Physician Income Guarantees

The System has entered into multiple physician recruiting agreements whereby the hospital provides financial assistance to a physician who is relocating his or her medical practice into the hospital's service area and community under which the System supplements physician income to a minimum amount over a period of time, typically one year, while the physicians establish themselves in the community As part of the agreements, the physicians are required to continue to provide medical services in the community for a period of time after the initial start up year, typically three years

The System records an asset and liability for the estimated fair value of the minimum revenue guarantees. The asset and liability represent the maximum amount of all unpaid minimum revenue guarantees, net of physician drawdowns, and is reported in other long-term assets and other long-term liabilities in the accompanying combined balance sheets. As of June 30, 2011 and 2010, the System had a liability of approximately \$3,175,000 and \$3,085,000, respectively

Income Taxes

Due to their organizational structure, certain of the System's entities are taxable under the Internal Revenue Code and some entities are tax exempt but are required to pay income taxes for unrelated business activities. The overall impact of federal income taxes to the System's combined financial statements is not significant. In addition, certain of the System's entities file partnership income tax returns in the U.S. federal jurisdiction and franchise tax returns in the State of Texas.

The Texas franchise tax applies to certain of the System's entities for any tax reports filed on or after January 1, 2008 The tax is calculated on a margin base and is therefore reflected in the System's combined statements of operations and changes in net assets for the years ended June 30, 2011 and 2010 as income tax expense

The System follows the provisions of ASC 740 "Income Taxes." As of June 30, 2011 and 2010, the System had no material gross unrecognized tax benefits

Insurance

BHCS provided for the basic self-insured retention limits for hospital professional liability and general liability coverage for 2011 and 2010 through the Self Insurance Retention Trust (SIRT) Excess policies that covered claims that exceeded \$10,000,000 per incident and \$50,000,000 in the aggregate for hospital professional liability and claims that exceeded \$2,000,000 per incident and \$7,000,000 in the aggregate for general liability in both 2011 and 2010 were provided by Health Care Insurance Company of Texas (HCICT), a wholly owned insurance company of BHCS domiciled in the Cayman Islands

Notes to Combined Financial Statements - continued

The excess policies were reinsured by ACE Limited, Lexington Insurance Company, Beazley Group Plc, Barbican Syndicate, Catlin Group, Chaucer Plc, Alterra Insurance Europe Limited, and Swiss Re in 2011 Although most of these carriers were consistent with 2010, there were slight changes in the layers provided in 2011 and Munich Re America was replaced by the Barbican Syndicate

BHCS provided for the basic self-insured retention limits for professional liability coverage for physicians in HealthTexas Provider Network, a wholly owned subsidiary of BHCS, through the SIRT An excess policy that covered claims for physician liability that exceeded \$750,000 per incident and \$15,000,000 in the aggregate in 2011 and 2010 was provided by HCICT and reinsured by ACE Limited in both years for limits of \$250,000 per medical incident and \$7,000,000 in the aggregate

To minimize its exposure to credit risk associated with reinsurance, the System continuously evaluates and monitors the financial condition of its reinsurers. At June 30, 2011, the System's reinsurers had an AM Best rating of at least A- ("Excellent") Management does not anticipate any material losses as a result of these concentrations. All of the System's insurance business comprises insurance of certain risks of the System and affiliates who are all engaged in the provision of medical and health care services. Accordingly, the System's underwriting risks are not diversified.

Liabilities for outstanding claims, including estimates for claims incurred but not reported, as well as reported claims pending settlement, are actuarially determined and discounted using an interest rate of 2% in 2011 and 2010. Total undiscounted reserves for losses and loss adjustment expenses were approximately \$63,959,000 and \$59,262,000 at June 30, 2011 and 2010, respectively. Total discounted reserves for losses and loss adjustment expenses at a seventy-percent confidence level were approximately \$71,235,000 and \$66,364,000 at June 30, 2011 and 2010, respectively.

Reserves for Losses and Loss Adjustment Expenses

The reserves for losses and loss adjustment expenses represent the SIRT's estimates using case basis evaluations and actuarial analysis, which are based on the SIRT's loss history data and industry loss statistics. The reserves for losses and loss adjustment expenses are based upon management's best estimate of the ultimate liability for outstanding losses and loss adjustment expenses determined in comparison with historical loss statistics. Management believes that the reserves for losses and loss adjustment expenses are adequate. However, because of the extended period of time over which losses are settled and the general uncertainty surrounding the estimates, the ultimate settlement cost of the losses and the related loss adjustment expenses could vary and these differences could be material. The estimate is continuously reviewed and, as adjustments to the liability become necessary, they are reflected in current operations.

Contributions and Gifts

When received or pledged, unrestricted gifts are reported as contributions to unrestricted net assets, and donor-restricted items are reported as contributions to temporarily or permanently restricted net assets. These donor-restricted contributions are restricted as to use and, when applicable, are transferred from temporarily restricted net assets to unrestricted net assets when the restrictions are satisfied and the related funds are appropriated for expenditure by the Board

Appropriations from the Baptist General Convention of Texas of approximately \$178,000 and \$176,000 in 2011 and 2010, respectively, are included in other operating revenue in the accompanying combined statements of operations and changes in net assets

Temporarily and Permanently Restricted Net Assets

Temporarily restricted net assets consist of contributions and pledges received and receivable These assets are donor restricted as to use and are transferred from temporarily restricted net assets to unrestricted net assets when the restrictions are satisfied Temporarily restricted net assets are primarily available for patient care, education, and research

Permanently restricted net assets consist of contributions received and receivable with donor restrictions that the principal be invested in perpetuity and only the income from the investments be expended for designated purposes. Income on endowment funds restricted for specified purposes is reported in the accompanying combined statements of operations and changes in net assets as temporarily restricted realized and unrealized investment income (loss)

Income on endowment funds which is required by donors to be invested in perpetuity is reported in the accompanying combined statements of operations and changes in net assets as permanently restricted realized investment income and unrealized gain (loss) on investments

Revenue and Gains in Excess of Expenses and Losses

The combined statements of operations and changes in net assets include revenue and gains in excess of expenses and losses. Changes in unrestricted net assets which are excluded from revenue and gains in excess of expenses and losses, consistent with industry practice, include unrealized gains (losses) on investments other than trading securities, permanent transfers of assets to and from affiliates for other than goods and services, and contributions of long-lived assets (including assets acquired using contributions which by donor restriction were to be used for the purpose of acquiring such assets)

Derivative Financial Instruments

ASC 815, "Derivative and Hedging" requires that all derivative financial instruments be recognized in the financial statements and measured at fair value regardless of the purpose or intent for holding them Changes in the fair value of derivative financial instruments are

recognized periodically either in operations or in other changes in unrestricted net assets depending on whether the investments qualify for hedge accounting The System's policy is to not hold or issue derivatives for trading purposes and to avoid derivatives with leverage features

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenue and expenses during the reporting period Actual results could differ from those estimates

Reclassifications

Certain reclassifications were made to the 2010 financial statements to conform to the 2011 presentation

Fair value measurements

As defined in ASC 820, fair value is based on the prices that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, ASC 820 establishes a three-tier fair value hierarchy for disclosure of fair value measurements. The valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. The three levels are defined as follows

• Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, and inputs that are observable by market participants for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument
- Level 3 Inputs that reflect the reporting entity's own assumptions about the assumptions market participants would use in pricing the asset or liability are unobservable and developed based on the best information available in the circumstances

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement

The carrying values of cash and cash equivalents, THVG funds due from United Surgical Partners, Inc, patient accounts receivable, other receivables, assets held as collateral – securities lending program, investments of insurance subsidiaries, accounts payable, accrued liabilities, and estimated third-party payer settlements payable are reasonable estimates of their fair value due to the short-term nature of these financial instruments

Fair values of short-term investments and long-term investments are generally based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data for substantially the full term of the assets Inputs are obtained from various sources including market participants, dealers, and brokers This applies to investments such as domestic equities, U S treasuries, exchange-traded mutual funds, and agency securities

In conjunction with the acquisition of TMC, BHCS purchased \$46,000,000 of Metrocrest Hospital Authority (MHA) bonds The bonds mature five years after issuance and bear an interest rate of 12 0% payable monthly Payments will be interest only for the first five years and the bonds are collateralized by a first and prior liens on unencumbered assets owned by MHA having an aggregate value of \$46,000,000 The bonds are reported in unrestricted long-term investments in the accompanying combined balance sheets

Alternative Investments

Investments held consist of marketable securities as well as securities that do not have readily determinable fair values Private equity investments, real estate investments and hedge funds are collectively referred to as "alternative investments" These are included in unrestricted long-term investments in the accompanying combined balance sheets, other than those held at BFT The investments in alternative investments are valued by management at fair value utilizing the net asset value (NAV) provided by the underlying investment companies unless management determines some other valuation is more appropriate. Such fair value estimates do not reflect early redemption penalties as the System does not intend to sell such investments before the expiration of the early redemption periods The fair values of the securities held by limited partnerships that do not have readily determinable fair values are determined by the general partner and are based on historical cost, appraisals, or other estimates that require varying degrees of judgment If no public market exists for the investment securities, the fair value is determined by the general partner taking into consideration, among other things, the cost of securities, prices of recent significant placements of securities of the same issuer, and subsequent developments concerning the companies to which the securities relate As this valuation methodology is based primarily on unobservable inputs These investments represent Level 3 assets

Included in collective investment funds held at BFT for the BHCS Foundation are alternative investment interests in private equity funds and oil and gas interests. These interests are included in restricted long-term investments in the accompanying combined balance sheets. These alternative investments are in limited partnership interests and are carried at the NAV provided by the underlying investment companies unless management determines some other valuation is more appropriate. As this valuation methodology is based primarily on unobservable inputs, these investments represent Level 3 assets. Also included in Level 3 assets for the BHCS Foundation are other real estate and oil and gas interests which are carried at lower of cost or market.

Beneficial Interest

The BHCS Foundation records charitable remainder trusts for which it is not the trustee at the discounted present value of the estimated future cash flows. These trusts are reported in contributions receivable, net, in the accompanying combined balance sheets. When a third-party serves as trustee, the beneficial interest is required to be measured at fair value on a recurring basis. As beneficial interests utilize multiple unobservable inputs, including no active markets, and are measured using management's assumption about risk inherent in the valuation technique, beneficial interests in split-interest agreements represent Level 3 assets

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values Furthermore, while the System

believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date

funds are actively managed commingled investment vehicles that include strategies such as distressed debt, merger arbitrage, relative value, and long-short equity strategies. The fair values of the investments in this category have been estimated using the net asset value per share of the investments. Investments in this category often have initial "lock-up" restrictions that do not allow investors to seek redemption ranging from one to three years. Following the initial lock-up period, liquidity is generally available monthly, quarterly, or annually following a redemption request which requires 30 to 90 days written notice.

Long-term Debt

The System's long-term debt obligations, excluding capital leases, are reported in the accompanying combined balance sheets at carrying value which totaled approximately \$901,925,000 and \$701,236,000 at June 30, 2011 and 2010, respectively The fair value of these obligations at June 30, 2011 and 2010, as estimated based primarily on quoted market prices for related bonds, totaled \$931,093,000 and \$795,490,000, respectively

4. ENDOWMENTS

The System's endowments consist of donor restricted and management-designated endowment funds for a variety of purposes. The net assets associated with endowment funds are classified and reported based on the existence or absence of donor imposed restrictions.

The System has interpreted the "Uniform Prudent Management of Institutional Funds Act" (UPMIFA) as not requiring the maintaining of purchasing power of permanently restricted endowment funds absent explicit donor stipulations to the contrary. As a result of this interpretation, the System classifies as permanently restricted net assets, (a) the original value of gifts donated to the permanent endowment, (b) the original value of subsequent gifts to the permanent endowment, and (c) accumulations to the permanent endowment made in accordance with the direction of the applicable donor gift instrument at the time the accumulation is added to the fund. The remaining portion of the donor-restricted endowment fund that is not classified in permanently restricted net assets is classified as temporarily restricted net assets until those amounts are appropriated for expenditure of the System in a manner consistent with the standard of prudence prescribed by UPMIFA. In accordance with UPMIFA, the System considers the following factors in making a determination to appropriate or accumulate endowment funds

- 1) The duration and preservation of the fund
- 2) The purposes of the Foundation and the donor restricted endowment fund
- 3) General economic conditions
- 4) The possible effect of inflation and deflation
- 5) The expected total return from income and the appreciation of investments
- 6) Other resources of the organization
- 7) The investment policies of the organization

Endowment Funds with Deficits

From time to time, the fair value of assets associated with individual donor-restricted endowment funds may fall below the value of the initial and subsequent donor gift amounts (deficit). When donor endowment deficits exist, they are classified as a reduction of unrestricted net assets. Deficits of this nature reported in unrestricted net assets were approximately \$390,000 and \$5,456,000 as of June 30, 2011 and 2010, respectively. These deficits resulted from unfavorable market fluctuations and authorized appropriation that was deemed prudent

Return Objectives and Risk Parameters

The System follows an investment policy that attempts to provide a predictable stream of funding to programs supported by its endowment while seeking to maintain the purchasing power of endowment assets. Under this policy, the return objective for the endowment assets, measured

Notes to Combined Financial Statements - continued

over a full market cycle, shall be to maximize the return against various indices, based on the endowment's target allocation applied to the appropriate individual benchmarks

The System expects its endowment funds over time, to provide an average rate of return of approximately 5 0% annually Actual returns in any given year may vary from this amount. To achieve its long-term rate of return objectives, the System relies on a total return strategy in which investment returns are achieved through both capital appreciation (realized and unrealized gains) and current yield (interest and dividends). The System targets a diversified asset allocation that places greater emphasis on equity-based investments to achieve its long-term objectives within prudent risk constraints.

Relationship of Endowment Spending Practices to Investment Objectives

The System primarily determines the appropriation of endowment funds for expenditure through an annual budgeting A distribution policy for primarily all of the endowments governs the amount of endowment funds that may be appropriated during this process. In establishing this policy, the System considered the long-term expected return on primarily all of its endowments Accordingly, over the long-term, the System expects the current distribution policy to allow its endowments to grow at an average of the long-term rate of inflation and maintain its purchasing power. In order to maintain the purchasing power of endowment assets, expenditures are based on investment performance and spending is curbed in response to deficit situations. The budgeted and approved allocations are distributed at the end of each month from the current net total or accumulated net total investment returns for individual endowment funds. Over the long term, the System expects its endowment to grow consistent with its intention to maintain the purchasing power of the endowment assets as well as to provide additional real growth through new gifts

The Revenue Bonds issued by BHCS and the Medical Center, the Series 2000 Taxable Notes issued by BHCS, and the Taxable Bank Line of Credit issued by BHCS, are entitled to the benefit of a Master Indenture of Trust and Security Agreement (MIT) dated May 1, 1998, under which the BHCS Obligated Group, which includes BHCS, the Medical Center, Baylor All Saints Medical Center (BASMC), the Baylor Medical Centers at Garland, Waxahachie, and the Baylor Regional Medical Centers at Grapevine and Plano, is obligated for payment BASMC, the Baylor Medical Centers at Garland, Waxahachie, and Baylor Regional Medical Centers at Grapevine and Plano became members of the BHCS Obligated Group in January 2008

In March 2008, BHCS entered into a three-year taxable revolving line of credit with Bank of America, N A and JP Morgan Chase Bank, N A In June 2011, this facility was expanded to \$275,000,000 with the addition of two new banks Under this line of credit, BHCS may borrow at variable rates through June 13, 2014 As of June 30, 2011 there was \$15,000,000 borrowed under this line of credit

In June 2011, BHCS issued \$359,220,000 Hospital Revenue Bonds through the Tarrant County Cultural Education Facilities Finance Corporation Proceeds net of underwriter's discount, totaling approximately \$364,815,000 were used to repay \$75,000,000 in borrowings under the taxable revolving line of credit and refund \$150,000,000 of Series 2006B and 2006C Revenue Bonds Bond proceeds were also used for capital projects totaling approximately \$19,707,000 The remaining bond proceeds were deposited into the proceeds fund's general account for costs of issuance and future project expenditures

Included in the 2011 issuance were windows variable rate demand bonds. These bonds are subject to long-term amortization periods and may be put to the System at the option of the bondholders in connection with certain remarketing arrangements. To the extent the bondholders may, under the terms of the debt, put their bonds within 12 months after June 30, 2011, the principal amount of such bonds has been classified as a current obligation in the accompanying combined balance sheets. Management believes the likelihood of a material amount of bonds being put to the System to be remote. However, to address this likelihood, management has taken steps to provide various sources of liquidity in the event any bonds would be put

BHCS has entered into interest rate swap agreements to manage interest rate risk. All of BHCS's swaps were entered into in order to convert existing or planned future variable rate debt to a fixed rate mode. Dislocations in the credit markets have caused management to reconsider its debt management plans, and as a result, management believes that some of the BHCS swaps no longer meet their planned purpose. As a result, some of these swaps may be terminated or restructured in the future as market conditions evolve.

In conjunction with the refunding of the Series 2006B and 2006C Revenue Bonds, BHCS paid \$11,250,000 to terminate two interest rate swaps with a notional value of \$100 million. Prior to its termination, the swap was in an unrealized loss position with all changes in value flowing through unrealized gains or losses in the non-operating section of the statement of operations and changes in net assets. Upon termination, the unrealized loss associated with the swap was reclassified as a realized loss in the non-operating section of the statement of activities. Since the underlying debt was discharged, the entire loss was recognized in the current year versus being deferred through interest expense as prescribed by ASC 815 – Derivatives and Hedging

None of BHCS's swaps are designated as hedging instruments. Net cash payments during the years ended June 30, 2011 and 2010 totaled \$16,666,000 and \$14,037,000, respectively. The mark to market increase in value of the swap portfolio for the fiscal year ended June 30, 2011 was \$9,239,788 including the swaps terminated in June 2011. The increase in net cash payments during fiscal year 2011 was due to the impact of forward starting swaps put in place during fiscal year 2008 that only became effective starting in May 2011 and a low short term variable rate environment. Additional forward swaps will become effective in November 2012 unless they are restructured.

6. NONCONTROLLING INTERESTS

The System controls and therefore consolidates certain investees of its subsidiaries. The System regularly engages in the purchase and sale of noncontrolling interests in these investees that do not result in a change of control. These transactions are accounted for as equity transactions as they are undertaken among the System, its consolidated subsidiaries, and noncontrolling interests, and their cash flow effect is classified within financing activities. The System now reflects noncontrolling interests in subsidiaries as either noncontrolling interests – redeemable in the mezzanine section of the combined balance sheets, or noncontrolling interests – nonredeemable in net assets in the combined balance sheets, according to ASC 810

7. NET PATIENT CARE REVENUE

BHCS has agreements with third-party payors that provide for payments to BHCS at amounts different from its established rates Payment arrangements include prospectively determined rates per case, reimbursed costs, discounted charges, and per diem payments. Net patient care revenue (exclusive of charity care – see Note 8) is reported at the estimated net realizable amounts from patients, third-party payors, and others for services rendered, including estimated contractual adjustments under reimbursement agreements with third-party payors

Contractual adjustments are accrued on an estimated basis in the period the related services are rendered and adjusted in future periods as final settlements are determined. These contractual adjustments are related to the Medicare and Medicaid programs and managed care contracts. The System offers a 35 0% discount to uninsured patients.

Net patient care revenue from the Medicare and Medicaid programs accounted for approximately 30 0% and 29 0% of total net patient care revenue in 2011 and 2010, respectively Net patient care revenue from managed care contracts accounted for approximately 64 0% and 64 0% of total net patient care revenue in 2011 and 2010, respectively

Notes to Combined Financial Statements - continued

Federal Regulations require the submission of annual cost reports covering medical costs and expenses associated with services provided to program beneficiaries. Medicare and Medicaid cost report settlements are estimated in the period services are provided to beneficiaries. Laws and regulations governing the Medicare and Medicaid programs are extremely complex and subject to interpretation. As a result, there is a reasonable possibility that recorded estimates may change by a material amount as interpretations are clarified and cost reports are settled

These initial estimates are revised as needed until the final cost report is settled Net patient care revenue from the Medicare and Medicaid programs increased approximately \$10,151,000 and \$20,033,000 in 2011 and 2010, respectively, due to changes in allowances previously estimated for amounts due to Medicare and Medicaid, as a result of changes in regulations and final settlement of numerous cost reports

Texas Medicaid State Plan Amendment 05-011, effective November 12, 2005, authorized implementation of the State Medicaid Private Hospital Upper Payment Limit Program (UPL Program) The UPL Program provides for supplemental inpatient and outpatient hospital Medicaid payments to hospitals that enter into an indigent care affiliation agreement with a hospital district or other local government entity and that satisfy certain other requirements. The goal of the UPL Program is to support local public officials' efforts to improve access to health care for needy persons in their communities and to enable local governments to support increased Medicaid payments to hospitals that provide services to a substantial number of Medicaid recipients in their communities. As of June 30, 2011, BHCS and BHCS entities participate in three indigent care affiliation agreements under the UPL Program, the Dallas and Neighboring Counties Indigent Care Affiliation Agreement, the Tarrant County Affiliation Agreement, and the Somervell County Indigent Care Affiliation Agreement

BHCS (on behalf of Baylor University Medical Center, Baylor Medical Center at Irving, Baylor Medical Centers at Garland and McKinney d/b/a Baylor Medical Center at Garland, Baylor Institute for Rehabilitation (removed from the affiliation effective April 1, 2011), Baylor Specialty Health Centers d/b/a Our Children's House at Baylor, Baylor Specialty Health Centers d/b/a Baylor Specialty Hospital, Baylor Regional Medical Center at Plano, and Baylor Medical Center at Waxahachie), and Baylor Heart and Vascular Center, L L P (BHVC) are parties to the Dallas and Neighboring Counties Indigent Care Affiliation Agreement (Dallas Affiliation Agreement or Dallas Affiliation) Other parties to the Dallas Affiliation Agreement are certain other private hospitals and the Dallas County Hospital District, dba Parkland Health & Hospital System (Parkland) Any party may withdraw from the Dallas Affiliation Agreement without penalty as of the expiration of the then-current term by providing at least seven days prior notice to all other parties So long as Parkland does not withdraw from the Dallas Affiliation Agreement, its provisions shall remain for all remaining parties upon the withdrawal of any individual private hospital

The private hospitals formed the Dallas County Indigent Care Corporation (DCICC), a Texas not-for-profit corporation DCICC entered into a Master Services Agreement with The University of Texas Southwestern Medical Center at Dallas (UT Southwestern) and also entered into certain other agreements with UT Southwestern and with Parkland In addition, the private hospitals entered into a certain contractual arrangement amongst themselves All of these arrangements are intended to further the purpose of the Dallas Affiliation and facilitate participation by the private hospitals in the UPL Program

As parties to the Dallas Affiliation Agreement and underlying agreements, BHCS and BHVC are subject to extensive federal and state laws, regulations, conditions of participation and certification requirements The Dallas Affiliation Agreement and the underlying agreements were structured considering these laws, regulations, and conditions of participation and certification requirements

For the fiscal years ended June 30, 2011 and 2010, BHCS and BHVC have received approximately \$78,801,000 and \$88,868,000 respectively in UPL Program supplemental payments BHCS and BHVC have accrued additional estimated supplemental payments under the UPL Program totaling approximately \$8,870,000 and \$12,983,000, respectively at June 30, 2011 and 2010 Under the Master Services Agreement between DCICC and UT Southwestern, DCICC is obligated to pay UT Southwestern for services furnished to indigent patients irrespective of UPL Program supplemental payments made or not made to the private hospitals, including BHCS and BHVC The aggregate compensation to be paid by DCICC to UT Southwestern under this Master Services Agreement is not set in advance but must be consistent with the fair market value for the services provided by UT Southwestern For the fiscal years ending June 30, 2011 and 2010, BHCS and BHVC (through DCICC) paid UT Southwestern approximately \$18,457,000 and \$30,336,000, respectively for services performed under the Master Services Agreements In addition, BHCS and BHVC have paid or accrued certain other expenses of approximately \$3,499,000 and \$4,128,000 respectively, at June 30, 2011 and 2010 and are recorded as other operating expenses in the combined statements of operations and changes in net assets

Effective May 31, 2009, Baylor All Saints Medical Center, dba Baylor All Saints Medical Center at Fort Worth and Baylor Medical Center at Southwest Fort Worth (BASMC), and Baylor Regional Medical Center at Grapevine (BRMCG), along with certain other private hospitals and the Tarrant County Hospital District, dba JPS Health Network (JPS), entered into the Tarrant County Indigent Care Affiliation Agreement (Tarrant Affiliation Agreement or Tarrant Affiliation) Any party may withdraw from the Tarrant Affiliation Agreement without penalty as of the expiration of the then-current term by providing at least thirty days prior notice to all other parties So long as JPS does not withdraw from the Tarrant Affiliation Agreement, its provisions shall remain for all remaining parties upon the withdrawal of any individual private hospital

The private hospitals formed the Tarrant County Indigent Care Corporation (TCICC), a Texas not-for-profit corporation As of June 30, 2011, TCICC had fifteen effective professional medical service agreements with physician groups and other providers to furnish physician and other health care services to indigent patients at JPS health care facilities TCICC also entered into a certain administrative support agreement with JPS and the private hospitals entered into a contractual arrangement amongst themselves All of these are intended to further the purpose of the Tarrant Affiliation and facilitate participation by the private hospitals in the UPL Program

As parties to the Tarrant Affiliation Agreement and underlying agreements, BASMC and BRMCG are subject to extensive federal and State laws, regulations, and conditions of participation and certification requirements. The Tarrant County Affiliation Agreement and underlying agreements were structured considering these laws, regulations, and conditions of participation and certification requirements.

For the fiscal years ended June 30, 2011 and 2010, BASMC and BRMCG have received approximately \$14,966,000 and \$12,007,000, respectively, in UPL Program supplemental payments BASMC and BRMCG have accrued additional estimated supplemental payments under the UPL Program totaling approximately \$1,162,000 and \$5,458,000 in 2011 and 2010, respectively. Under the various professional medical services agreements between TCICC and the physician groups and other providers, TCICC is obligated to pay for services furnished to indigent patients irrespective of UPL Program supplemental payments made or not made to the private hospitals, including BASMC and BRMCG. The aggregate compensation to be paid by TCICC to the physician groups and other providers under these professional medical services agreements is not set in advance but must be consistent with the fair market value for the services provided by the physician groups. For the fiscal year ended June 30, 2011, BASMC and BRMCG (through TCICC) paid the physician groups and other providers \$10,896,000 and \$10,829,000 in 2011 and 2010, respectively. In addition, BASMC and BRMCG have paid or accrued certain other expenses of approximately \$79,000, at June 30, 2011, included in other operating expenses in the combined statements of operations and changes in net assets

Effective June 30, 2011, Baylor University Medical Center (BUMC) entered into the Somervell County Indigent Care Affiliation Agreement with the Somervell County Hospital Authority, d/b/a Glen Rose Medical Center (Medical Center), and Somervell County, Texas (Somerville Affiliation Agreement or Somerville Affiliation) As of such date, BUMC had not yet entered into professional services agreements with other providers to furnish professional or medical services at the Medical Center in furtherance of the Somerville Affiliation As a party to the Somerville Affiliation Agreement, BUMC is subject to extensive federal and state laws, regulations, and conditions of participation and certification requirements The Somerville Affiliation Agreement was structured considering these laws, regulations, and conditions of participation and certification requirements

8. CHARITY CARE

The System provides care to patients who lack financial resources and are deemed medically or financially indigent. Because the System does not pursue collection of amounts determined to qualify as charity care, these amounts have been removed from net patient care revenue as described in Note 7 above. The charges related to this care along with estimates for possible future charity care write-offs related to current accounts receivable totaled approximately \$307,802,000 and \$264,819,000 in 2011 and 2010, respectively. The estimated direct and indirect cost of providing these services, calculated using the ratio of patient care cost to charges, was \$120,236,000 and \$108,373,000 in 2011 and 2010, respectively. In addition, the System provides services through government-sponsored indigent health care programs (such as Medicaid) to other indigent patients

The System also commits time and resources to endeavors and critical services which meet otherwise unfulfilled community needs Many of these activities are entered into with the understanding that they will not be self-supporting or financially viable The expenditures for medical research activities and direct medical education are reported in Note 10

9. RETIREMENT BENEFITS

Effective January 1, 2002, a 401(k) defined contribution plan that was administered by ING was made available to all eligible employees Effective January 1, 2011, AON Hewitt became the net administrator of the 401(k) defined contribution plan Employees are eligible to contribute to the plan immediately with no minimum service or age requirement. The System matches amounts contributed by employees, up to 50% of the employee's base compensation. Employees vest in the System's matching contribution over five years. Retirement benefits equal the amounts accumulated to the employee's individual credit at the date of retirement.

The System's contributions to the 401(k) plan totaled approximately \$38,163,000 and \$35,784,000 for 2011 and 2010, respectively, which are included in salaries, wages, and employee benefits expenses in the accompanying combined statements of operations and changes in net assets

Two defined contribution retirement plans administered by MetLife were provided for employees of All Saints Health System prior to the purchase by BHCS. These plans were frozen to employee and employer future contributions as of January 1, 2002, with the purchase by BHCS and all accounts were immediately vested. All Saints Health System employees now participate in the plans offered through the System.

Notes to Combined Financial Statements - continued

ASC 715, "Compensation – Retirement Benefits," requires the System to recognize the funded status (i.e., the difference between the fair value of plan assets and the benefit obligation) of its defined benefit pension and other postretirement benefit plans in the combined balance sheets with a corresponding adjustment to unrestricted net assets. The net unrecognized actuarial losses and unrecognized prior service benefits are recognized as a component of future net periodic cost pursuant to the System's policy for amortizing such amounts. Further, actuarial gains and losses that arise in subsequent periods and are not recognized as net periodic pension cost in the same periods are recognized as other changes in unrestricted net assets. Those amounts are recognized as a component of net periodic cost.

The System and six of its affiliated hospitals provided a defined benefit plan, the Baylor Health Care System Retirement Security Plan (the "BEST Plan"), for employees, which was discontinued on January 1, 1984

The overall long-term investment objective for the All Saints Plan is to meet plan funding obligations by achieving the annual return targets established for the plan, specifically to earn an annualized rate of return of 70% over a full market cycle, defined as three to five years, and outperform customized indices. Actual returns in any given year may vary from these amounts. To accomplish such objective, a balanced investment approach is employed, with target allocation for plan assets that places greater emphasis on equity-based investments within prudent risk constraints. The Irving Hospital Authority ("Authority") entered into a Master Agreement ("Master Agreement") with Irving and BHCS and a Lease Agreement ("Lease Agreement") with Irving

Under the terms of the Lease Agreement, Irving agreed to manage and lease substantially all properties of the Authority over an initial lease term of 20 years, beginning August 1, 1995, with an option to renew the lease for two additional 10 year terms. The Lease Agreement has been accounted for as an operating lease with annual base rent payments of \$7,000,000 per year. An Amended and Restated Lease Agreement ("Revised Lease Agreement") was entered into by the Authority and Irving effective April 1, 2010, to extend the lease thirty five years through March 31, 2045, and to supersede nearly all the obligations of the original Master Agreement and Lease Agreement

The Revised Lease Agreement is accounted for as a capital lease with (a) fixed rent payments of approximately \$8,825,000 per year, as adjusted by a September 24, 2010 amendment to the Revised Lease Agreement, plus (b) a contingent rent payment equal to 200% of the excess operating cash flow derived from the prior fiscal year's operations, as defined in the Revised Lease Agreement Irving has accrued \$5,939,000 at June 30, 2011 for the contingent rent payment due to the Authority on November 1, 2011

BHCS signed a Limited Joinder to evidence its agreement with the BHCS obligations included in the Revised Lease Agreement and to covenant that BHCS will pay the rent and the early termination fee/liquidated damages if Irving fails to pay those obligations. During the initial six year term of the Revised Lease Agreement, Irving pays BHCS a management fee, based on a percentage of the excess operating cash flow, as defined in the Revised Lease Agreement. BHCS continues to be required to contribute \$100,000 per year to Irving, to be matched by the Irving Healthcare Foundation, for community health projects, which are mutually agreed upon by BHCS and Irving BHCS contributed \$100,000 directly to Irving in 2011 and 2010, respectively. At the end of the lease term the leased facilities will be surrendered to the Authority. At June 30, 2011, no liability under the Revised Lease Agreement was recorded as no amount can be reasonably estimated.

In November 1998, BHCS renewed the affiliation agreement with Hopkins County Memorial Hospital (HCMH) for an additional term of five years In 2003, BHCS notified HCMH that the renewal would be continued on a year to year basis Under the affiliation agreement, BHCS will provide certain services which include, but are not limited to, physician recruiting, managed care strategies, information systems, facilities development, community needs assessment, financial and tax services, marketing, and public relations for an agreed-upon fee

In February 2009, BHCS signed an affiliation agreement with Wise Regional Health System for an initial term of five years. Under the affiliation agreement, the System will provide certain services including continuing education, legal consulting, physician recruiting and group purchasing for an agreed-upon fee

Notes to Combined Financial Statements - continued

The healthcare industry is subject to numerous laws and regulations of federal, state, and local governments. These laws and regulations include, but are not necessarily limited to, matters such as licensure, accreditation, government healthcare program participation requirements, reimbursement for patient services, physician ownership and self-referral, and Medicare and Medicaid fraud and abuse. Government activity has continued with respect to investigations and allegations concerning possible violations of fraud and abuse statutes and regulations by healthcare providers. Violations of these laws and regulations could result in expulsion from government healthcare programs together with the imposition of significant fines and penalties, as well as significant repayments for patient services previously billed. Management believes that the System is in compliance with applicable fraud and abuse laws and regulations as well as other applicable federal and state laws and regulations.

12. SUBSEQUENT EVENTS

On July 15, 2011, the System entered into a term loan agreement with Bank of America and the proceeds were used to redeem the 1998 series bonds totaling approximately \$91,655,000 million A loss on extinguishment of debt of approximately \$1,314,000 million was recorded upon the redemption of the 1998 series bonds

On September 15, 2011, the System provided notice of redemption on the outstanding 2001A series bonds. The bonds were redeemed on October 17, 2011 for a redemption price of \$51,100,000. A loss on extinguishment of debt of approximately \$1,700,000 was recorded upon the redemption of the 2001A series bonds.

The System has performed an evaluation of subsequent events through November 1, 2011, which is the date the financial statements were available to be issued

OTHER COMMUNITY BENEFITS - UNAUDITED

Nonprofit hospitals are required to report community benefits under the requirements of Texas Health and Safety Code Chapter 311 BHCS reports its required community benefits as a hospital system which includes all BHCS nonprofit hospitals with the exception of Baylor University Medical Center and Our Children's House at Baylor which are reported separately as these hospitals, due to their Medicaid Disproportionate Share status, are excluded and deemed by the State of Texas to be in compliance with the requirements of Chapter 311

For Texas state law purposes, unaudited community benefits include the unreimbursed cost of charity care, the unreimbursed cost of government-sponsored indigent health care (i e, Medicaid), and the unreimbursed cost of government-sponsored health care (i e, Medicare), medical education, and other community benefits and services. The amount of community benefits reportable for Texas state law purposes by all BHCS nonprofit hospitals, including Baylor University Medical Center and Our Children's House at Baylor, totaled approximately \$473,608,000 and \$493,975,000 in 2011 and 2010, respectively
