MannaRelief operates the Hope program that focuses on providing spiritual encouragement and nutritional supplements to children who are under doctor's care. Children selected for the program receive monthly nutritional products. Additionally, the families receive spiritual support from the staff of MannaRelief. In 2010, the Hope program was able to provide support to 782 children.
