Houston Volunteer Lawyers Program - Founded by the HBA in 1981, this program provides free legal services to citizens who do not meet the stringent criteria for federal legal aid programs, but who still cannot afford legal representation The program is supported by grants from the Houston Bar Foundation, IOLTA, the Legal Services Corporation, the Ryan White Foundation, Basic Civil Legal Services fees, the Texas Bar Foundation, the Low Income Tax-payer Clinic, and private contributions Volunteer attorneys provide all legal services pro bono HVLP offers basic family law training clinics to local law firms and corporate legal departments in order to assist attorneys in handling family law matters During this year, an additional \$50,000 grant was given to HVLP for Free Legal Advice Clinic for Veterans and spouses of deceased Veterans at the Michael DeBakey VA Hospital in Houston's medical center

The Houston Bar Association's Juvenile Justice Mock Trial Program is now in its 37th year of teaching young teens about law and the legal system As part of social studies, history, or government classes, students at over 40 participating schools in the Houston area work with the law students and HBA staff to learn about the procedures involved in a courtroom trial Over a five-week period, the students develop their own case story and assume the roles of judge, jurors, attorneys, defendants, plaintiffs, and witnesses At the end of the unit, the classes travel to the Harris County courthouse complex where they act out their mock trial in an actual courtroom The program focuses on eighth grade students, but has worked with special classes of fourth, fifth, and sixth graders, including classes for hearing-impaired students The program has reached more than 37,000 students in the Houston area, encouraging respect for the judicial system and discouraging entry into the system in a negative way
