IT MEETS AS NEEDED TO REVIEW THE COMPENSATION PROGRAM AND TO MAKE RECOMMENDATIONS FOR ANY CHANGES, AS APPROPRIATE. WHILE THE ORGANIZATION FOCUSES ON COMPARABLE NONPROFIT ORGANIZATIONS IN ITS AREA TO BENCHMARK COMPENSATION, IT ALSO UNDERSTANDS THAT THE MARKET FOR EXECUTIVE TALENT MAY BE BROADER THAN THIS GROUP. MARKET INFORMATION FROM TWO ADDITIONAL MARKET SEGMENTS, PRIVATE FOUNDATIONS AND PUBLISHED NONPROFIT COMPENSATION SURVEYS, MAY BE USED AS A SUPPLEMENT. TOGETHER WITH DATA FROM COMPARABLE LOCAL ORGANIZATIONS, DATA FROM THESE MARKET SEGMENTS ARE USED TO FORM A "MARKET COMPOSITE" TO ASSESS THE COMPETITIVENESS OF COMPENSATION. THE COMPENSATION COMMITTEE PRESENTS ITS FINDINGS AND RECOMMENDATIONS IN AN EXECUTIVE SESSION WITHOUT THE CHIEF EXECUTIVE PRESENT, AND MAKES RECOMMENDATIONS TO THE FULL BOARD OF DIRECTORS FOR REVIEW AND APPROVAL. THE COMPENSATION COMMITTEE CHAIR AND/OR THE CHAIR OF THE BOARD MEET WITH THE CHIEF EXECUTIVE TO DISCUSS THE DECISION.
