

FCE HAS DEVELOPED A COMPREHENSIVE COLLEGE RETENTION PROGRAM TO SUPPORT AND GUIDE FCE STUDENTS TO ENSURE THAT THEY OBTAIN A BACHELOR'S DEGREE. ONE HUNDRED PERCENT OF FCE'S STUDENTS GRADUATE FROM HIGH SCHOOL AND ENROLL IN POST-SECONDARY INSTITUTIONS. EIGHTY-FIVE PERCENT OF FCE COLLEGE STUDENTS COMPLETE COLLEGE WITHIN FIVE YEARS.

FCE'S COLLEGE SCHOLARSHIP PROGRAM HELPS ADDRESS THE GREATER FINANCIAL NEEDS OF ITS STUDENTS PROVIDING SUSTAINABILITY GRANTS AND HENCE, PLAYS A KEY ROLE IN RETENTION.
