THE INITIAL PENNREN NETWORK BUILD, CONSISTING OF OVER 1600 MILES OF FIBER AND 62 NODE LOCATIONS, WILL BE FINISHED IN SPRING 2013. IN ADDITION TO THE 11 CHARTER MEMBERS, KINBER HAS ATTAINED SIX NEW MEMBERS.
