On October 8 and 10 of 2010, Intermountain Opera Bozeman produced two performances of  
the Gala, "BRAVO! An Opera Celebration" reaching an audience of over 1500. This  
concert style program featured outstanding guest artists: Layna Chianakas, Cynthia Clayton,  
Robert McDonald, John Pickle, Elizabeth Croy and Margaret Kohler, singing favorite arias from 15 different  
operas. 60 local musicians along with over 130 volunteers were involved in the production.  
Outreach and educational activities associated with "BRAVO!" included, a free lecture demo open to the public giving  
insights into voice types, details of the different arias and the operas they were from that were to be performed. Guest artists  
performed for and answered questions at local middle and high school music/choral classes. A continuing  
education component of Montana State University, "Wonderlust", held an opera class with 65 attendees,  
with presentations by guest artists, the stage director, artistic director and conductor.

The class was also invited to see the dress rehearsal prior to the performances of "BRAVO!" On May 11, 13 & 15, 2011, Intermountain Opera Bozeman produced three performances of Rossini's "The Barber of Seville" sung in Italian with English supertitles. This production included seven guest artists from out of town, a men's chorus of 15, an orchestra of 27, stage/production crew of 15 and over 150 volunteers. Local opera vocalist Suzanne Gorder provided a free class for the community on "The Barber of Seville." Ms. Gorder gave background on "Rossini" the story behind the opera and gave musical demonstrations from the opera. On Friday prior to performances over 750, 5th and 7th graders were bussed to the performance venue for a behind-the-scenes look at what it takes to produce an opera. Guest artists visited and performed for the choral classes at the high school. The local adult education class offered an "opera field-trip" as its May class. This class gave the participants a chance to get to learn about "The Barber of Seville" and opera in general before seeing the dress rehearsal.
