**AMENDMENT TO AMENDED AND RESTATED BYLAWS
OF
TENTH MOUNTAIN DIVISION HUT ASSOCIATION ENDOWMENT FUND, INC.**

This Amendment (this "Amendment") to the Amended and Restated Bylaws of Tenth Mountain Division Hut Association Endowment Fund, Inc. (the "Company") amends the Bylaws of Tenth Mountain Division Hut Association Endowment Fund, Inc. as amended and restated as of February 14, 2002, and effective as of February 14, 2003, a copy of which is attached hereto as Exhibit A (as amended from time to time, the "Bylaws").

AGREEMENT

NOW, THEREFORE, by unanimous consent of the Board of Directors of the Company, the Bylaws are hereby amended as follows:

**SECTION 1.
AMENDMENT TO NAME OF COMPANY**

The name of the Company is hereby changed from "Tenth Mountain Division Hut Association Endowment Fund, Inc." to "Tenth Mountain Endowment Fund, Inc.", and accordingly, each reference in the Bylaws to "Tenth Mountain Division Hut Association Endowment Fund, Inc." is hereby deleted and replaced with "Tenth Mountain Endowment Fund, Inc.".

**SECTION 2.
AMENDMENT TO ARTICLE III**

1. Article III, Section 2 of the Bylaws is hereby amended as follows:
