Resource Center- Direct ServicesDirect Services is here for those in need when there is no place else to turn Our food pantry, clothing bank, and warehouse facilities make Springs Rescue Mission El Paso County's largest provider of life's essential items Direct Services is strategically networked to provide the right help as quickly as possible through our extensive partnerships with other local agencies In an effort to not duplicate services, SRM focuses on areas that will create impact in the lives of the impoverished in our community in the area of basic living needs In fiscal year 2011, over 38,000 clients were served through Direct Services Almost 90 tons of clothing, 3,600 furniture items and appliances, 6,636 hygiene packs, and almost 1,400 bibles were distributed Through our Direct Services food pantry, 28,724 meals were distributed through food boxes and an additional 85,000 lbs of food was provided to our partner agencies to help stock their food pantries

Samaritan's Kitchen - Meals & Food ProgramOur meal program provides hot meals six days a week In FY11, meals served in the Samaritan's Kitchen and those provided through food boxes, provided almost 200,000 meals (222,931 lbs) of food to the hungry SRM hosted numerous events on and off site to feed those in need in our community including "The Best Christmas Ever" that touched the lives of almost 4,000 families with 762 bicycles, 8,000 Christmas gifts, as well as a meal, food box, and a turkey for each family A total of over 50,000 lbs of food was distributed during the Best Christmas Ever Another 7,000 lbs of food and 2,200 coats were distributed at "Christmas for All" hosted by SRM at the the Colorado Springs City Auditorium In addition, SRM partnered with the Department of Human Services during their "Feed the Children" Christmas event and provided over 1,200 turkeys for families in need Through food boxes distributed from the SRM food pantry, over 2500 meals were provided during the Christmas season SRM's "Great Thanksgiving Banquet" provided 2459 hot meals and another 1,200 meals were provided through food boxes During the Easter season, 872 meals were served during our Easter dinner and another 1,200 meals were provided thru food boxes

Recovery Programs - New Life Program Springs Rescue Mission currently provides a 12-18 month residential recovery program for men suffering from addictions, including chronic alcoholism and drug addiction Plans are in motion to expand the men's recovery program to include a facility expansion project which will enable us to house an additional 40 men SRM comes alongside men on their journey from dysfunction and addiction to new life based on relationship with Jesus Christ They learn accountability and trust in a safe environment so they can fight their addictions and other self-destructive tendencies The New Life Program focuses on recovery and healing for broken men Through drug and alcohol recovery, intensive counseling, job training and education, these men learn how to live free of substance abuse, maintain healthy relationships, and hold a permanent job In fiscal 2011 we provided 15,380 bed nights through the New Life Program Collaborative relationship with partnering agencies and churches continue to strengthen our ability to provide solid exit plans, mentors, housing, and jobs, as graduates move into aftercare
