Any reported violations of the conflict of interest policy are aggressively investigated and properly resolved.</p> <p>SECTION B, LINE 15B PROCESS FOR DETERMINING COMPENSATION - Every five years, the University hires a compensation consulting firm to review the compensation of its President, officers, and key employees and compares this information to other Universities throughout the country. Based on this review, the consultants make recommendations to the University concerning the compensation of these individuals. The most recent review was performed during the fiscal year ended June 30, 2009. Annually, the University performs the following procedures:</p> <ol style="list-style-type: none"> <li>1. Reviews compensation information of other Universities throughout the country. This information is obtained from 990's for nonprofit Universities and 10k filings for proprietary Universities.</li> <li>2. Participates in a nationwide employee compensation survey.</li> <li>3. The President reviews the officers and key employees' personal performance for the previous fiscal year in relation to goals and objectives previously established for that individual and the University as a whole. Based on this review, the President determines any compensation adjustments for the current fiscal year.</li> <li>4. The Compensation Committee of the Board of Trustees reviews the President's personal performance for the previous fiscal year in relation to previously established goals and objectives of the University. Based on this review, the Committee determines any compensation adjustments for the President in the current fiscal year.
