YOUTH SHELTERS PROVIDES A FULL CONTINUUM OF SERVICES TO HOMELESS, RUNAWAY, AND IN-CRISIS YOUTH AND THEIR FAMILIES THROUGH FOUR PROGRAMS: FIRST CONTACT STREET OUTREACH, YOUTH EMERGENCY SHELTER, TRANSITIONAL LIVING AND COMMUNITY COUNSELING. THE AGENCY SERVES AN AVERAGE OF 900 - 1,000 EVERY YEAR.

THE YOUTH EMERGENCY SHELTER IS A 24HOUR SUPERVISED FACILITY PROVIDING SAFE SHELTER TO RUNAWAY, HOMELESS AND IN-CRISIS YOUTH AGES 10-17 FOR UP TO 30 DAYS. YOUTH RECEIVE FOOD, HOUSING, CASE MANAGEMENT, COUNSELING AND LIFE SKILLS TRAINING. THE SHELTER SERVES ON AVERAGE 150 UNDUPLICATED YOUTH ANNUALLY.

THE TRANSITIONAL LIVING PROGRAM (TLP) SERVES YOUTH AGES 16-21 IN A SUPERVISED APARTMENT SETTING FOR UP TO 18 MONTHS. YOUTH WORK TOWARD SELF-IDENTIFIED GOALS GEARED TO ASSIST IN THE TRANSITION TO INDEPENDENCE. SERVICES INCLUDE CASE MANAGEMENT, COUNSELING, AND LIFE SKILLS TRAINING. WITH THE COMPLETION OF FIVE NEW APARTMENTS IN MARCH 2010, THE PROGRAM HOUSES UP TO 14 YOUTH. TLP CURRENTLY SERVES APPROXIMATELY 33 YOUTH INCLUDING PREGNANT AND/OR YOUTH WITH CHILDREN ANNUALLY.

THE FIRST CONTACT STREET OUTREACH PROGRAM PROVIDES CRUCIAL SUPPORT TO HOMELESS, RUNAWAY AND AT RISK YOUTH, UP TO AGE 22, VIA STREET-BASED OUTREACH AND A CENTRALLY LOCATED DROP-IN CENTER. SERVICES INCLUDE ACCESS TO BASIC NEEDS SUCH AS FOOD, CLOTHING, HYGIENE ITEMS, CAMPING GEAR, SHOWERS AND LAUNDRY, CASE MANAGEMENT SUPPORT IN AREAS SUCH AS EDUCATION, EMPLOYMENT, HOUSING AND HEALTH (INCLUDING PRE/POST NATAL SUPPORT) AND COUNSELING SERVICES. THE PROGRAM SERVES ON AVERAGE 500-600 UNDUPLICATED YOUTH ANNUALLY.
