IN FISCAL YEAR 10-11, PARTNERS AWARDED NEARLY \$56,000 IN CLASSROOM TEACHER GRANTS TO 65 TEACHERS FOR INNOVATIVE EDUCATIONAL PROJECTS THAT THE SCHOOL DISTRICT COULDN'T PAY FOR. PARTNERS PROVIDED BUS TRANSPORTATION FOR APPROXIMATELY 1,000 EDUCATIONAL FIELD TRIPS, AN AVERAGE OF SIX TRIPS EVERY SCHOOL DAY. PARTNERS SERVED 1,800 STUDENTS AND 80 TEACHERS WITH AN AESTHETIC EDUCATION METHODOLOGY THAT INTEGRATES THE ARTS INTO THE REGULAR CLASSROOM CURRICULUM.
