HOURS OF OPERATION RANGE FROM 2:00PM TO 6:00PM MONDAY THRU FRIDAY DURING THE SCHOOL YEAR, AND OFFERS AN ENRICHMENT MODEL OF SERVICES. THIS INCLUDES HOMEWORK HELP, AND ACADEMIC ENRICHMENT IN SMALL GROUPS TO ENSURE PROPER STUDENT TO TEACHER RATIOS ARE MAINTAINED. WE USE CERTIFIED SCHOOL TEACHERS TO HELP DELIVER OUR SERVICES TO ENSURE PROGRAMS ARE OF "HIGH QUALITY". THE NUMBER OF STUDENTS REGISTERED IN OUR PROGRAMS ARE 742, AND THE TOTAL NUMBER OF STAFF EMPLOYED BY OUR PROGRAMS ARE 69.

CYFD SUPPORTS PROGRAMMING BY QUALIFYING PARENTS TO RECEIVE THE CHILD CARE SUBSIDIES BASED ON PARENT QUALIFICATIONS.
