	Goodwill Industries of Southern Arizona, Inc. operates 11 thrift stores, 3 outlets, 1 salvage operation and 1 auction facility in Southern Arizona. Goodwill's retail program gave back to the community by providing 468 jobs to Tucson workers at these retail locations and touched the lives of over 20,000 men, women, and children by generating funding for educational and vocational programs. \$5,817,680 in income was earned in wages and benefits by adults trained or employed by Goodwill, supporting the local economy and dramatically reducing welfare assistance. 840,343 people benefitted from low-cost purchases in the eleven retail stores. 351,973 donors provided donated material goods. 19,006,543 pounds of goods were recycled and diverted from landfills.

Described in a summary below are the ways in which Goodwill and direct partners served approximately 34,405 men, women and children last fiscal year.

Goodwill Industries of Southern Arizona, Inc. (Goodwill) provides educational, training, and support services to increase employability of individuals with barriers to employment; through community-based facilities. Annually, 3,069 people are served through Goodwill's educational and training programs and Goodwill's 4 Job Connection Centers, located at the retail store/donation sites, receive 11,219 visits. Other valuable services include youth mentoring, youth work experience training, employee assistance, and career development services. Highlights of these services include:

Goodwill's Job Connection Centers provide job search assistance including career planning, resume development, assistance in conducting an internet job search, interview skills training, and referral to appropriate job openings. All services at the centers are free of charge and are available by appointment or on a walk-in basis. Goodwill's Job Connection Centers also provide referrals to community support services including family counseling, day care assistance, ESL or GED training, financial literacy training, tax filing assistance, and food boxes. Visitors to Goodwill's Job Connection Centers can build a resume, apply for jobs online, search the job posting board, and learn about training and other educational opportunities available throughout Southern Arizona.

Goodwill's Ready to Earn Computer/Customer Service Training program is specifically designed to provide individuals with the entry-level skills needed for successful employment in Tucson's Call Center Industry with starting wages of \$8.00- \$12.00 per hour. Goodwill's Ready-to-Earn Training program is highly respected by area employers and has won three national awards. This program is accredited under CARF-the Commission on Accreditation of Rehabilitation Facilities- Employment Skills Training and licensed by the Arizona Board for private Postsecondary Education.

Goodwill's Job Opportunity Center provides paid work and sheltered employment services for adults with disabilities who are too severely disabled to work in the community. Goodwill's Job Opportunity Center provides these individuals with a sheltered – protected - safe work environment in which they receive the support they need and real pay for real work. Services provided through Goodwill's Job Opportunity Center are accredited under CARF-the Commission on Accreditation of Rehabilitation Facilities-Organizational Employment. Individuals must be referred and supported by the State of Arizona- Division of Developmental Disabilities (DES-DDD) or the State of Arizona- Rehabilitation Services Administration (DES-RSA).

Goodwill's Youth Mentoring Program is an exciting and innovative program to help at-risk youth build career plans, prepare for school completion, post-secondary training, and productive work by providing structured activities and supportive relationships with trained adult volunteer mentors. The program targets youth between the ages of 12 and 17 who are facing legal trouble, are at-risk for dropping out of school, or are at risk of delinquency due to issues such as abuse, disability, drug or alcohol dependence, or gang membership. Through this program; Goodwill also supports the families of enrolled youth by providing assistance in accessing community resources including our Job Connection Centers.

Goodwill Industries of Southern Arizona provides employee assistance and career development services to our employees. Before becoming employed by Goodwill, over 85% of our employees were considered low-income individuals. Because these employees face a wide variety of barriers to employment including welfare dependency, long-term unemployment, ex-offender, low academic skills, undiagnosed disabilities, etc.; Goodwill provides comprehensive Career Development services for all employees. Under this program, employees have access to individualized, one-on-one career development services through a full-time Career Development Specialist. Services are tailored to meet the needs of the employee and designed to assist the employee in advancing their career within Goodwill and/or to pursue career advancement opportunities outside of Goodwill. Services include, but are not limited to, referral to appropriate day care, referral to ESL and/or GED classes, referral to family counseling services, referral and funding assistance to attend Community College or other approved training programs.

Goodwill's After School and Summer Youth Work Experience program provides low-income Pima County youth with real work at area businesses. Youth receive a paycheck and both job specific skills and work ethic skills- skills they will take with them into adulthood, skills that will assist them to become productive, working members of our community.
