A DAILY NUTRITIOUS MEAL, CONTAINING 1/3 OF THE RECOMMENDED DAILY ALLOWANCE IS PREPARED AND DELIVERED TO PARTICIPANTS THROUGH 1 OF 9 CONTRACTED SERVICES PROVIDERS AND DIRECTLY THROUGH PGCSC.
