Open Inn's outreach program provides 24 crisis intervention and support for homeless teens through a network of Safe Place sites throughout Pima County. Street based outreach services including assessment, case management, basic needs, reproductive health care, and food are provided to homeless youth and young adults at a circuit of parks, rec centers, transit stations, malls and other places youth congregate. Open Inn's walk-in Youth Resource Center provides case management, basic needs, showers, hygiene and health items, food, discussion and educational groups, activities and referrals for homeless youth and young adults. Case management services are provided to homeless and near-homeless young adults ages 18-25 to promote self-sufficiency. Project Safe Place aims to provide a safety net for at-risk, runaway and homeless children under the age of 18. Open Inn continued to employ Teen Peer Counselors in order to engage and build trust with the youth. In Fiscal Year 2011, outreach was conducted at all four of our locations that serve at total of seven Arizona counties. All together, our outreach efforts made over 19,000 youth contacts, distributed approximately 16,000 basic need items and over 614 entered additional case management programs. Throughout Southern Arizona, Open Inn maintained over 400 Safe Place Sites and distributed over 10,000 promotional materials along with presentations to the community.
