Tucson Centers for Women and Children has been doing business as **Emerge! Center Against Domestic Abuse** since April 2008 when it merged with Brewster Center Domestic Violence Services. Emerge! operates two shelters in Tucson, Arizona with a total of 120 beds; a 24/7 bilingual crisis hotline; two walk-in support centers for individuals not in need of shelter; support groups; a transitional housing program, a child care center for 84 children; and a community education program to help prevent future violence and promote community awareness.

Emerge!'s programs go beyond immediate safety for the women and families it serves. Once the immediate crisis is stabilized, Emerge! staff work with families to develop life skills that lead toward self-sufficiency. Programs are tailored to meet the specific needs of each participant. All of our services offer safety planning and education in addition to clinical support. The average number of days participants stay in shelter is 32 days.

Emerge! won the Workplace Excellence Award of Greater Tucson in 2011 for its innovative hiring practices. Emerge! is dedicated to a well-trained, healthy team of staff, and actively engages in promoting a positive, productive work environment.

This year past Emerge!:

- Provided more than 40,000 safe nights of shelter to women and their children
- Provided crisis intervention for nearly 2,200 people
- Provided more than 2,000 people with case management
- Provided nearly 3,000 people with safety planning
- Provided support to nearly 5,000 callers to the 24/7 crisis hotline
- Helped more than 600 people to understand their rights, obtain orders of protection, obtain legal services and otherwise navigate the legal system through our lay legal program
