The New Day Center Campus has programs for Emergency Shelter 66 rooms with expenditures of 2,245,575 Its Transitional Housing 46 rooms had expenditures of 1,180,483 Operations and facilities had expenditures of 19,949 The Emergency Shelter and Transitional Housing programs for homeless families are held in the on-campus facility In addition to housing, the organization provides training in budgeting, life skills, parenting and GED certification among other useful skills to the adult members of the families Also, employment services, such as, writing resumes, filling out applications for employment, and job searches are provided on campus UMOM helped more than 1,000 individuals in the Emergency Shelter program and more than 325 individuals in the Transitional Housing Program In both programs, nearly 62 of participants were children under 17

4b (Code) (Expenses \$ 1,031,592 including grants of \$) (Revenue \$)

The Watkins Overflow Shelter program provides low demand shelter services for 120 single women and 20 families. The City of Phoenix owns the facility and UMOM works in partnership with the City of Phoenix in providing these services. In addition to having a warm place to sleep, program participants are provided meals, hygiene items, clothing and medical attention, as well as case management and other supportive services provided by UMOM and the City. In-kind donated goods of 80,754 are included in expenditures.

4c (Code) (Expenses \$ 950,558 including grants of \$) (Revenue \$)

The New Day Center operates a Childcare Center for the children of the families in the emergency and transitional programs. The Childcare Center is licensed by the State of Arizona to serve 98 children infants through 12 years. This program also provides evaluation of developmental and behavioral issues and includes an after school program for ages 6 through 12 years.
