and moderate income families. Primavera's neighborhood revitalization
activities include purchase, rehabilitation/replacement of REO-owned
distressed homes that are rented or sold to first-time homebuyers and
replacement of owner-occupied distressed housing. Making homes livable
and safe increases the value of the home and also creates positive
change in the community.

Emergency Shelter - Street outreach, drop-in day centers and overnight
shelters, and immediate relief for families and individuals who are

Work Force Development - Primavera's employment services assist

individuals annually.
