

Individual Tax Credit: CTODP collected \$9,139,113 in state tax credit funds from 13,511 individual tax payers under the Private Education Individual Tax Credit (A.R.S. 43-1089) from July 1, 2010 to June 30, 2011. The statute allows for a \$500 credit per taxpayer (\$1,000 for married filers) against any State of Arizona tax liability.

Corporate Tax Credit: CTODP raised \$3,544,510 from 28 qualified corporations and insurance companies which took advantage of the Private Education Corporate Tax Credit (A.R.S. 43-1183, A.R.S. 20-224). The statutes allow for eligible companies to receive a dollar-for-dollar credit against any State of Arizona corporate tax liability and insurance premium tax liability, respectively, up to a defined aggregate statewide cap. For Fiscal Year 2011, the available cap was set at approximately \$20.1 million.

Grants (Scholarships) to Directors/Employees: All families with registered students in a Diocese of Phoenix Catholic School, including dependents and/or relatives of Board/Staff members, are welcome to apply to CTODP for scholarship support. All applications and tax forms are mailed by the applicant directly to a third-party vendor, Financial Aid Independent Review (FAIR), located out of state. Individual applications are not handled, reviewed, or processed by the Board/Staff of CTODP for the determination of any awards. Individual award decisions are made by FAIR based on FAIR's determination of a family's ability to pay tuition. The CTODP Staff executes the program, and CTODP Board of Directors oversees the process and monitors the allocations of funding by school, but not by individual families. At no time do Board/Staff members have influence on the individual award of a particular applicant. The process is specifically and intentionally designed to be "arms-length" for CTODP, not just for dependents or relatives of Board/Staff members but for every applicant.

FAIR Methodology: Tuition assistance is awarded by CTODP based on financial need. Applications are processed by Financial Aid Independent Review (FAIR) of Eagan, Minnesota. FAIR provides a third-party review of all applicants. Scholarships are based on calculated financial need of the applicant; thus tax forms are required. The application requires families to provide information about income and living expenses. FAIR methodology incorporates income, expenses, net worth, discretionary income, tuition and the amount of discretionary income available for tuition to calculate family need. Instead of providing a standard allowance based on household income and size, FAIR takes a different approach by using actual expenses as

provided by the family, and determining a family's ability to pay tuition.

Arizona state law requires that a minimum of 90 percent of total revenues received be distributed in the form of tuition grants/scholarships. During fiscal year end 2011, CTODP is proud to have distributed 92.7% of contributions received in fiscal year end 2010 to Catholic school students in the form of direct tuition assistance.
