Emergency Food Assistance - Catalina Community Services funded the food distribution through the Food Bank including the value of food donated to Catalina Community Services. On average, 320 families were received emergency food assistance each month.

Clothing Bank - Catalina Community Services funded the clothing distribution program including the value of clothing donated to this program. These donations make this program possible. We are now open five days each week, and serve more than 800 individuals each month.

The Food and Clothing Bank programs continued to grow. This first year in our new building brought us a 40% increase in client registration. We served more than 1500 people in the Greater Catalina area.

Senior Meals Program - Catalina Community Services funded the Senior Center and related activities this past year. The number of seniors receiving home delivered meals or who chose to attend the congregate meals program continues to increase each year. Plans are being made to build a larger facility - with a larger kitchen and dining space to accommodate the growing number of local struggling seniors .

Youth Programs - Catalina Community Services funds community based youth programming including a school-wide Junior Achievement program. Catalina Community Services is a major supporter of the "Youth Day" celebration in Catalina. Expenses incurred during the holiday season included Christmas gifts, seasonal clothing, jackets, hats, gloves, etc. Summer programs were held each business day, at the center this year, to encourage children to get off the couch and out from behind the television. Programs were designed to stimulate minds and bodies. Our Back to School program supplied more than 150 children with new clothing outfits, backpacks and supplies.

Community Education is a growing area for us. We offer ESL classes, citizenship classes, many community workshops and special events geared to improve residents' lives.

Being located in the far northwest rural corner of Tucson AZ, CCS is the sole local provider of many of these services. As a resource center, offering information and referrals as well as the services described above, we impact the lives of many. We have enrolled more than 3000 registered clients.
