WOMEN IN JEOPARDY - A TEMPORARY REFUGE FOR WOMEN AND CHILDREN WHO ARE VICTIMS OF FAMILY VIOLENCE; A PLACE WHERE RESIDENTS CAN OBTAIN IMMEDIATE SAFETY AND SUPPORT, FEEL WELCOME AND RESPECTED; GAIN ACCESS TO COMMUNITY RESOURCES; AND BECOME MORE EMPOWERED TO CREATE HEALTHY, VIOLENCE-FREE LIVES. BEDS WERE INCREASED DURING THIS YEAR WITH THE TWO ADDITIONAL FACILITIES ON CAMPUS IN THE MCCARTHEY AND HUNTSMAN RESIDENCES, TO A TOTAL OF 181 BEDS. LAST YEAR, OUR SHELTER PROVIDED 39,133 NIGHTS OF SERVICE TO 363 WOMEN AND 461 CHILDREN. LOLIE ECCLES CHILD CARE CENTER - NATIONALLY ACCREDITED, LICENSED CHILD CARE THAT PROMOTES A SAFE, NURTURING, RESPECTFUL PLACE WHERE YOUNG HOMELESS CHILDREN LIVING AT THE YWCA AND CHILDREN FROM THE LARGER COMMUNITY CAN LEARN, PLAY AND GROW TOGETHER. LAST YEAR, WE ADDED A DROP-IN CLASSROOM WITH AN ADDITIONAL 23 SLOTS TO FOCUS ON THE NEEDS OF THE FAMILIES IN RESIDENCE. LAST YEAR, 101,016 HOURS OF CHILD CARE WERE PROVIDED TO 267 CHILDREN INCLUDING 201 (75%) CHILDREN WHO LIVED AT THE YWCA SHELTER AND TRANSITIONAL HOUSING. FURTHER, 85% OF THE CHILDREN'S FAMILIES INCREASED THEIR INVOLVEMENT IN THEIR CHILD'S SCHOOLING AND EARLY LEARNING ACTIVITIES. FINALLY, THERE WAS A WAITING LIST OF MORE THAN 25 CHILDREN AT YEAR END.

CHILDREN'S ADVOCACY - ADVOCACY AND INTERVENTION SERVICES TO STRENGTHEN THE SAFETY, HEALTH AND WELL BEING OF CHILD VICTIMS OF FAMILY VIOLENCE WHO LIVE WITH THEIR MOTHERS AT THE YWCA. LAST YEAR, 592 CHILDREN EXPOSED TO FAMILY VIOLENCE BEGAN TO OVERCOME THEIR DIFFICULT EXPERIENCES THROUGH DAILY EMOTIONAL AND PRACTICAL SUPPORT DURING 9,792 HOURS OF CHILD-CENTERED ADVOCACY, AND 130 CHILDREN AND TEENS PARTICIPATED IN 16,847 HOURS OF ONSITE AFTER SCHOOL AND TEEN PROGRAMMING. 50% OF THE CHILDREN WHO LIVED AT THE YWCA LAST YEAR WERE UNDER SIX YEARS OF AGE.
