Community Action Food Bank alleviates hunger by providing food/basic needs packages, counseling, budgeting and referrals to other community services. The program provided 23,100 food and basic needs packages to 6,112 unduplicated households (16,732 people). The food bank also provided food to 25+ community partner organizations for distributions to their low-income clients. The total amount of food distributed was 4.4 million pounds. Community Action Food Bank operates several of its own food pantries located in Provo, Heber City, Kamas, and Coalville. The expenses include the value of the donated food and goods received from grocers, food industry, other nonprofits, USDA Commodities, farmers and through

The Family Development and Support Services Program provides a variety of direct services to help eligible households stabilize and work toward self-reliance. In FY 2011, 499 households were assisted in this program.

The HEAT (Home Energy Assistance Target) Program provides winter home heating assistance and year-round energy crisis intervention for eligible low-income households (especially families with children, persons with disabilities, and the elderly).
