An applicant for membership in the Brotherhood shall be one who has reached the minimum working age prescribed by statutory laws regardless of race, creed, color, sex, or national origin and who is working at some branch of the trade or employed in a shop, plant, or industrial facility where the International Brotherhood has jurisdiction at the time of making application and who, if a former member, has been suspended from membership for non-payment of dues for more than 48 continuous months. Generally, all members in good standing of Local 242 shall be entitled to be seated and to participate in meetings, vote in elections, have the right to express their views, arguments, or opinions upon any business properly before the meeting subject to the Constitutions and Local 242's bylaws.
