Unduplicated total of 1076 adults were served in fiscal 2011 receiving 10498 units of service. Units of service are defined as an event regardless of length of time. All recipients had major mental illnesses

Children's Community Support--Mental health services provided on an outpatient basis to children living in Pierce County. An unduplicated total of 655 children were served in fiscal 2011 receiving 6,621 units of service. All recipients had severe mental illnesses

Residential-Inpatient Mental Health Services--during fiscal 2011, 292 children and adults were served in these programs/facilities. As noted above for other programs, these individuals were diagnosed as having serious mental illnesses and were assessed as needing more structured, supportive and intensive services than those available on an outpatient basis. A total of 30,941 bed days of service were provided.
