In the 2010-2011 school year, University Child Development School (UCDS) enrolled 311 students. UCDS is committed to small classes with a maximum of 18 students and an average teacher to student ratio of 1:9. UCDS currently employs 25 classroom teachers, 10 resident teachers, and Spanish, physical education, art, music, science, technology and library specialists. The UCDS faculty has been nationally recognized for its excellence in educating children.

In 2010-2011, UCDS' childcare program served an average of 31 children/month. \$323,600 was spent on this program.

Teacher Education Center:

The UCDS Teacher Education Center (TEC) creates and cultivates professional development opportunities, innovative programs and educational partnerships. The TEC is committed to promoting teacher excellence and enhancing education at UCDS and in the broader community.
