The Agros model is a uniquely holistic approach to alleviating rural poverty By providing long-term land loans to the poor along with integrated services such as community organization, training, and long-term credit, entire rural villages are empowered to become self-sustaining and escape the devastating effects of extreme poverty Program initiatives undertaken in FY11 include the launch of a major new village and regional project in Nicaragua, serving 150 families in the new village and up to 600 more in the region, completion of direct support for nine communities that reached development milestones, continuation of three regional economic development projects in Guatemala serving 742 families, provided community and economic development training and assistance to 1300 families in Agros villages in Guatemala, El Salvador, Nicaragua, Honduras and Mexico During the year, 323 individuals participated in service teams to Agros villages
