In both cases, the work involves designing and delivering new region wide training sessions and developing coordinated campaigns to 1) build capacity and advance strategies that create living wage jobs through enterprises that also improve the quality of the environment, and 2) assist the leaders of faith and other non-profit organizations in adapting relational organizing practices to strengthen their institutions and more effectively advance their larger mission to improve their communities. Together, these initiatives trained over 40 leaders and engaged 100s in coordinated Green Economy campaign activities.
