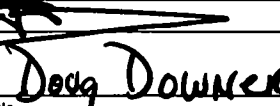

ABOUT THE BILL BERG SCHOLARSHIP

HISTORY:

The Foundation was originally funded by gifts from members of Greater Bend Rotary and from persons who gave gifts in honor of Bill Berg on his death in 1995. It is the plan of the Trustee's of the Foundation to accumulate capital until the fund reaches a sufficient size that it's income will permit continuing gifts in larger amounts and number. In the meantime, gifts are funded by continuing contributions from the members of Greater Bend Rotary. At present the amount given annually will also be guided by the requirements of the IRS for tax-exempt foundations.

At the present time, at least one scholarship of \$1200 will be given, although additional scholarships of various amounts may be granted to qualified applicants.

ELIGIBILITY:

The Greater Bend Rotary Club Foundation was established in 1995 by the Greater Bend Rotary Club of Bend, Oregon. The Foundation was established for two purposes. The first purpose was to honor a man who encouraged Rotary as a force for good in the world. The second purpose was to express that honor by giving assistance to young people who believe in the value of their lives, to themselves and to their community. To achieve these purposes, the Foundation grants Bill Berg Scholarships.

The foundation will consider applications from students who:

1. Will be graduating the year of the application from any high school in the Bend-LaPine School district, including any private high school within the District.
2. Have demonstrated that they value themselves and their goals.
3. Have applied to a college, technical or vocational school.
4. Are deemed to have good attitude for such continuing education.
5. Have good moral character and demonstrated good citizenship.
6. Financial need may be considered.

No preference will be given to any particular class of students and all students shall be evaluated by the same criteria. At the present time, the scholarship is limited to students graduating from high school the current year, and will not be available for succeeding years of study.

Awards will be paid directly to the educational institution on a pro rata basis.

HOW TO APPLY:

Application forms are available between February 1 and March 30th annually from the counseling office in the eligible high schools. Forms may also be obtained by writing to:
