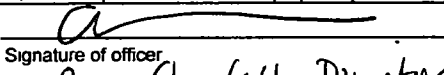
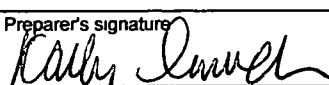

LOCAL GROUP SUPPORT & CAPACITY BUILDING ROP provided leadership support, trainings in communication systems and movement building analysis to the 50 member groups and hundreds of local volunteer organizers that make up the ROP. During the year, ROP staff organizers logged over 10,000 miles holding over 50 in-community meetings, strategy sessions and community events across the entire state. Working directly with the human dignity groups in their communities results in stronger local organizing and greater collective impact. Over the last year, ROP saw an increase in members and supporters to over 13,000 households representing all of Oregon's 36 counties. We communicated regularly via ROPnet, our email listserve and the Immigration Fairness Network list with over 2300 local leaders sharing strategies, analysis and regular updates on issues. In 2010 ROP developed a Latino Advisory Committee that held the first ROP Rural Latino Retreat in Feb of 2011. Over 50 Latino leaders representing a dozen rural counties convened to develop organizing strategies based on their experience. The Rural Caucus and Strategy Session in May 2011 engaged over 130 human dignity activists in strategy sessions and trainings on civic engagement, democratic economy, welcoming communities, immigration fairness and LGBTQ (lesbian, gay, bi, transgender, queer) justice.

CIVIC PARTICIPATION. ROP'S civic engagement work combines strategic statewide collaboration with groups that share our values with support for small town communities to have their voices heard. In the 2010 election, ROP worked with local groups to engage community members in conversation about the issues that came up. Oregon faced 7 ballot measures. Over 60 volunteers were trained, over 200 volunteers were engaged, 2600 doors were knocked on. ROP distributed over 40,000 STAND voter guides in all 36 Oregon counties. Our voter guide not only featured the standard ROP analysis of ballot measures, but also incorporated a Democratic Economy framework throughout the guide and held up each ballot measure against that frame. This laid the groundwork for our 2011 legislative organizing. In the 2011 legislative session ROP Participated in at least 5 Days of Action at the Capitol, Sent over a dozen delegations to Salem to meet with legislators; Made hundreds of legislative contacts via phone calls, emails & letters; Submitted dozens of letters to the editor on issues we care about; Testified in favor of Drivers Licenses, Anti-Wage Theft policy, the Oregon State Bank and Single Payer Health Care, and Organized or participated in nearly 20 local forums, strategy sessions & gatherings on our issues. ROP's platform promoted a Democratic Economy. Put People First, Hold Accountable those responsible for the Economic Recession, & Promote Real Security through community empowerment & energy conservation.

IMMIGRATION FAIRNESS. ROP'S organizing for immigration fairness has focused on building more welcoming communities across rural and small town Oregon as a proactive strategy to build more united, successful and harmonious communities. The vision of Welcoming is to decrease hostility and eventually create welcoming environments for immigrants by organizing for both cultural shift and policy change. Local highlights of the Welcoming Communities organizing include In the wake of a failed attempt to pass an E-Verify measure in Polk Co, our member organization, Polk Cafe Commons, organized a welcoming campaign. They held cross-cultural community events to look at the issue of immigration & are distributing a shared mission statement as a sign-on campaign. In Lincoln Co, the Immigration Information Response Team held a forum to address racial profiling and police-ICE collaboration. They have seen a drop in deportations stemming from minor traffic infractions. Leaders are now going city by city to pass Welcoming Resolutions. ROP worked closely in 6 counties on immigrant fairness campaigns. In addition ROP supported another 2 dozen communities to hold a total of 33 events, including 16 community events with over 600 participants for the bilingual "No Soy El Army" peace tour.

Human dignity groups responded by demanding an economy that represents small-town community values and democratic principles. ROP and our member groups have been innovating Hometown Strategies for a Democratic Economy to create sustainable local economies, from Move Your Money campaigns to foreclosure defense strategies. 14 member groups representing 9 counties have piloted Hometown Projects to build a more democratic economy. Our member groups came together for a shared action for economic fairness and launched the Foreclose on Walden campaign in Spring of 2011 when over 130 rural Oregonians marched to Congressman Walden's Bend office to post a Notice of Foreclosure for his failure to look after the financial and social welfare of his state. We then sent him, via certified mail, a copy of the Notice of Foreclosure from every county in the state.

Revenue: 0 QUEER RIGHTS & GENDER JUSTICE. ROP worked with ally organizations and our member groups in rural Oregon on the Our Towns project. ROP offered direct support to 8 communities from Grants Pass to La Grande to engage in the strategy around marriage equality. Leaders hosted over a dozen house parties and community gatherings, reaching hundreds of people. Award winning filmmakers of "Out in the Silence" toured across Oregon bringing communities into moving and ongoing dialogue. We hosted 15 stops on this tour, got 1000 people in the room with us, and reached thousands more through the press, conversations and online.
