The mission of the Good Shepherd Community Health Foundation is to enhance the quality of life and general health of residents living in the West Umatilla and Morrow County communities Resources are provided to worthy projects best illustrating foundation ideals and fulfilling the health needs of our designated region 2011 is the sixteenth anniversary of the Good Shepherd Community Health Foundation which at fiscal year end had an asset balance of \$2,872,351 The Good Shepherd Community Health Foundation uses judiciously the interest off of our endowments and donations received from direct appeal campaigns and fundraisers, such as our Scramble for Scholarships Golf tournament and special events, to fund projects in keeping with our mission In December 2010 we partnered with the Hermiston morning Kiwanis club and sponsored a tree in their annual Festival of Trees fundraiser In June 2011 we held our 17th annual Scramble for Scholarships golf tournament and raised nearly \$10,000 specifically to fund people in the community seeking health care careers In May 2011 the foundation awarded \$12,000 in scholarship funds to thirteen students Three \$1,000 scholarships to current GSMC employees seeking Nursing degrees, \$1,000 to a Walla Walla University nursing student, \$1,000 to a BMCC nursing student, \$1,000 to an OHSU dentistry student, \$1,000 to a Creighton University medical school student, and \$1,500 to an OIT Medical Sonography student We also were able to award five local high school senior scholarships towards pursuit of health careers in dental hygiene, pre-medicine, nursing and physical therapy Foundation grants are awarded twice a year, in October and April Grants totaling \$81,602 16 were awarded this fiscal year as follows \$40,962 16 in grants were made to six designated charities including Eastern Oregon University, Blue Mountain Community College, Vange John Memorial Hospice, Domestic Violence Service West End Project, Humane Society of Eastern Oregon and from the interest on a bequest Mary Ellen Paul Other grants made by the Health Foundation this fiscal year include \$5,000 grant to Umatilla Morrow Head Start to provide support to the Healthy Start program of Umatilla County Healthy Start promotes wellness for all families when their first child is born \$7,500 awarded to the Agape House backpack weekend food program \$5,000 was awarded to Agape House in support of the construction of a local homeless shelter, "Martha's House" \$5,000 was awarded to Blue Mountain Community College to purchase equipment for the new wellness center \$4,000 was awarded to Hermiston Police department to purchase a trailer and Soda Blasting Machine to quickly remove graffiti from local property \$2,000 was awarded to Head Start to purchase safe cribs for local centers \$2,000 was awarded to Hermiston Fire department to purchase a Project SAFE Mobile unit for education local residents on safety topics \$1,500 was given to BMCC to purchase Automated External Defibrillators (AED's) \$1,400 to purchase playground equipment for the City of Irrigon playground\$1,325 to "Umatilla County Reduce Adolescent Pregnancy Partnership" to fund a speaker on healthy relationships, abstinence, dating and communication \$1,300 was awarded to Stanfield/Echo Little League to purchase first aid kits for each team \$1,040 was awarded the the GS Diabetes Education Department to assist in diabetes education \$1,000 was given to Umatilla County Fair board for purchase of Automated External Defibrillators \$930 grant was given to the Good Shepherd Education department to fund a pattern for Healthy Living luncheon \$800 to Hermiston High's Baseball team to install "Poly Cap" around the top rail of the baseball field fence \$500 was given to Dream Catcher Therapeutics to fund scholarships for equine assisted therapy \$345 was given to the Festival of TreesIn December 2010, the Foundation again sponsored the "Community Christmas Spirit Award" This award solicited nominations from the community of individuals who represent the Spirit of Christmas, the spirit of giving throughout the year Selected as the 2010 award winners were, Sandy Hickey and Jim Purswell
