ALDEA HAS PROVIDED PREMIER TREATMENT FOSTER CARE SERVICES TO CHILDREN AGES 0 TO 19 SINCE 1985. TREATMENT FOSTER CARE SERVES VULNERABLE CHILDREN WHO ARE REMOVED FROM THEIR BIRTH HOMES DUE TO SEVERE ABUSE, NEGLECT, OR EMOTIONAL DISTURBANCE. MASTERS LEVEL THERAPISTS STAFF WORK INTENSIVELY WITH THE FOSTER PARENTS IN ORDER TO PROVIDE A SAFE, NURTURING HOME WHERE CHILDREN CAN BEGIN TO HEAL FROM THEIR WOUNDS OF ABUSE.
