 Resource and Referral Program offers free child care referrals and community resource information in English, Spanish, Chinese, Russian, or Vietnamese. During FY 2010/11 the programs received 4,279 requests for referrals and provided technical assistance to 3,032 families.

During FY 2010/11, Children's Council's Subsidy Payments department provided child care subsidies for 3,734 children each month, allowing eligible parents to defray all or part of their child care costs. The department also enrolled 4,877 children in subsidized care programs through the San Francisco Centralized Eligibility List (SFCEL).

 Provider Services - During FY 2010/11, Children's Council's Provider Support Services team conducted 77 workshops and other educational opportunities for 1,335 (duplicated) child care providers, in English, Spanish, and Cantonese, providing a total of 275 hours of training and 4,757 student hours. During FY 2010/11, Children's Council's Health and Nutrition Services department distributed food to 718 families from low-income households during its summer food pantry. The department also provided monthly reimbursements to 300 providers for nutritious meals served to the 2,952 children in their care, and reimbursed providers for 108,236 healthy meals served to San Francisco children in child care each month. During FY 2010/11 Linking for Quality provided 1,507 hours of training and on-site coaching to 264 (unduplicated) ECE
