Child Development Department: Wu Yee's Child Development program supports young children to reach their potential by offering full-day and year-round high-quality subsidized child care services to children aged 0-5. Our target population is low-income and recent immigrant families who are working in job training or in school and need child care. The program is designed to provide comprehensive child care services, to integrate parent involvement, education, physical health, mental health, nutrition, special needs and social services to the families that Wu Yee serves.

Each year, Wu Yee's Child Development program delivers high-quality comprehensive child care to 265 children ages 0-5. We serve 223 at our

SF CARES: Wu Yee administers the San Francisco's Comprehensive Approaches to Raising Education Standards Program (SF CARES) that is designed to provide resources and financial incentives, and to promote professional development for teachers and child care providers in the early childhood education arena of San Francisco. Each year, Wu Yee's SF CARES program distributes over 951 stipends totaling over \$2.3 million to promote the education and professional development of the workforce and to improve the quality of child care.

Child Care Subsidy, Provider Training, Resource & Referral: Wu Yee's Child Resource & Referral program supports families, child care providers and local communities in finding, planning for and providing affordable, high quality child care. Each year, Wu Yee's Child Care Resource & Referral program supports over 900 families with finding child care resource and referral information.

Wu Yee's Child Care Subsidies program assists eligible low-income families in San Francisco with child care case management, referrals and payments to child care providers. Child care subsidies programs include Calworks Stage I and II, Family and Children's Services (FCS),
