 Appalachian Institute for Renewable Energy (AIRE) is a fiscally sponsored project of ISI and is located in Boone, NC. AIRE's mission is to help ensure that the benefits of our nurturing planet will remain available to current and future generations by reducing our society's continued use of fossil fuels for power generation. A leading voice for renewable energy in the Southeast & Appalachian region and by educating individuals and organizations about the choices and benefits of community based renewable energy. We will work in collaboration with other community groups, non-governmental organizations, renewable energy professional to improve access to and enhance the availability of affordable financing, including use of tax credits and other incentives, for purchasing and installing renewable energy systems. AIRE conducted detailed marketing research, analysis, operational plans & financial analysis and plans that resulted in a comprehensive and well-thought through strategic plan that was funded by Kendeda with a two year grant of \$200,000 per year. Coordinated worked cooperatively as a partner with Interfaith Power & Light to install a solar system for the First Congregational Church in Ashville, NC. Provided educational activities for local nonprofit organizations, schools, churches, business organizations and low-income citizens in area on renewable energy systems serving over 2200 people.

 Seedling Projects (SP) is a "do tank" for the sustainable food movement—transforming ideas into action. It specializes in getting food projects off the ground and building an active and diverse community around each project to ensure that it flourishes. As a mission driven organization, Seedling Projects aims to • Promote collaboration within the food movement • Build public demand for good food • Create new leaders for the sustainable food movement • Enable agricultural policy that favors a sustainable food system. Through focused events and strategic models we engage the public in finding better ways to feed our communities. SP has received initial funding Kaiser Permanente for the DC Schools on the Move project, and developing a garden and curriculum program EW Stokes school while building a strong base of support for a food and ecology curriculum amongst additional schools in the Washington DC area. Kaiser Permanente has provided additional grant support for the Future of Food event and for organizing managing other food related events in cooperation with their goals to improve nutrition in schools and families. An estimated 3500 school students, teachers and administrators have benefited from these educational programs and events and the pilot programs are expected to reach many thousands more through collaboration with other nonprofit and community organizations

 Bay Area Track Club (BATC) is committed to promoting professional and recreational running by offering a range of programs that serve the Bay Area's health and fitness needs. The Club strives to provide elite athletes support and access to training resources allowing them to excel at a world-class level. Through participation in and sponsorship of community fitness related events the club and its elite athletes contribute inspiration, mentoring and practical guidance to local runners of all ages. BATC will promote running and lifelong fitness to countless local residents through events such as instructional clinics, meet appearances, group fun runs, peer mentoring, motivational seminars, and running camps. These programs will supplement, educate, & enrich while also providing valuable resources to the spectrum of youth and adults pursuing an active lifestyle. BATC has conducted health and fitness events for local residents and school age children from throughout the Bay Area. An estimated 450 people, of all age groups and income levels, but especially very low-income children participated in the each of the two events held to date. BATC also provides support with training and travel stipends for encouraging young runners in their development. Funds been provided through grants from the Corporate & Foundation grants & USATF program for encouraging runners and youth fitness.
