FVLC's legal department is recognized throughout the community as the leader in providing top-quality legal services to people fleeing domestic violence. This year FVLC provided legal information, assessment, paperwork preparation assistance, advice and council and representation to 790 legal clients. FVLC helped 232 of those clients get 415 court orders.

The Education & Youth Services Department reached more than 2,400 youth (middle and high school students) through education, training, events and health fairs. The Relationship Abuse Prevention (RAP) youth leadership program enrolled 40 high school students through leadership classes and afterschool internship programming to work with middle school youth at our four partner schools. The leadership program is a weekly year-long elective course held within the school day that builds students' leadership skills by engaging them in advocating around the issues of dating and domestic violence. As part of this program, FVLC taught the Safe Dates curriculum to 618 students from 4 Oakland middle schools and trained 36 teachers at four partner middle schools providing them with a short workshop on the dynamics of teen dating violence.

Family Violence Law Center (FV LC) seeks to end family violence in Alameda County by providing support and advocacy for survivors of domestic violence, changing individual and community perceptions about relationship abuse, and advocating for change within the legal, health, education, and criminal justice systems.

As FVLC's primary crisis intervention unit, the Family Violence Intervention Unit (FVIU) responded to more than 3,308 police reports, and provided crisis intervention and case management to 1,845 clients, the majority of these clients resided in Oakland.

FVLC's Mobile Response Team (MRT) program served 494 domestic violence survivors in Alameda County by providing 24-hour crisis counseling, safety planning, temporary hotel relocation, transportation, advocacy and other services.

FVLC utilized the Client Assistance Fund providing immediate assistance to 44 clients leaving abusive relationships by providing rental assistance, hotel stays, emergency transportation, food, and assistance with bills (including utility and medical). This fund remains a lifeline for many survivors who are struggling with self-sufficiency after experiencing abuse.
