THERE WERE 19 PERFORMANCES EACH OF THE MIDDLE AGES, NOVEMBER, DOUBT, QUILTERS, RABBIT HOLE AND 18 PERFORMANCES OF PRIDE AND PREJUDICE. THE AUDIENCE BREAKDOWN VARIES FROM ONE PRODUCTION TO ANOTHER BASED ON THE PARTICULAR PLAY, INCLUDING SUCH FACTORS AS NAME RECOGNITION, PLAY CONTENT AND SUBJECT MATTER, WHETHER IT IS A CLASSIC OR WHETHER IT IS A NEW SCRIPT, AND WHETHER OR NOT THE PLAYWRIGHT IS WELL KNOWN.
