NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Description of Organization - Los Altos Educational Foundation (the "Foundation") is a nonprofit organization incorporated in the State of California. The Foundation receives direct public support from residents of and around the Los Altos School District (LASD) in Santa Clara County, California. All contributions received are for the benefit of the nine schools comprising LASD.

Basis of Accounting - The financial statements have been prepared on the accrual basis of accounting and accordingly, reflect all significant receivables, payables and other liabilities.

Basis of Presentation - The Foundation reports information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

- Unrestricted net assets are unrestricted resources available to support the Foundation's activities and income accumulated on endowment fund as well as Foundation Board designated funds.
- Temporarily restricted net assets consist of donor restricted contributions for which the applicable restriction was not met as of the end of the current year. There were no temporarily restricted net assets as of June 30, 2011 and 2010
- Permanently restricted net assets include resources that have been permanently restricted as to use by the donor and will neither expire by the passage of time nor be removed by actions of the Organization

Contributions - Contribution revenue is recognized when contributions are received or when the donor makes a pledge. All contributions are considered available for general operations unless specifically restricted by the donor.

Contributions that are restricted by the donor are reported as increases in unrestricted net assets if the restrictions expire (that is, when a stipulated time restriction ends or purpose restriction is accomplished), in the reporting period in which the revenue is recognized. All other donor restricted contributions are reported as increases in permanently restricted or temporarily restricted net assets, depending on the nature of the restrictions. When a restriction expires, temporarily restricted net asset are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restriction.

Functional Allocation of Expenses - The costs of providing the various programs and other activities have been summarized on a functional basis in the statement of activities. Accordingly, certain costs have been allocated among the program and support services benefited based on management's estimate.

In-Kind Support - The Foundation records various types of in-kind support including tangible assets, the use of tangible assets and professional services. The amounts reflected in the statement of activities as in-kind donations are offset by like amounts included in program expense. Donated equipment and other donated goods are recorded at their estimated value at the date of donation. Contributed services which require a specialized skill and which the Foundation would have paid for if not donated, are recorded at the estimated fair value at the time of service rendered. The Foundation also receives donated services that do not require specific expertise but which are nonetheless central to the Foundation's operations. These contributed services are not reflected in the financial statements.

Cash and Cash Equivalents - All highly liquid instruments with a maturity of three months or less are considered to be cash equivalents.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from these estimates.

Property and equipment - Property and equipment are recorded at cost, or if contributed, at the estimated fair value when donated. The Foundation generally capitalizes additions of property and equipment with a cost or fair market value in excess of \$500. Depreciation and amortization are computed using the straight-line method over estimated useful lives. Depreciation expense for the year ended June 30, 2011 was \$59. There was no depreciation expense in 2010.

Income Taxes - Los Altos Educational Foundation is exempt from income taxes under Section 501(c)(3) and Section 23701(d) of the Internal Revenue Code and California Revenue and Taxation Code, respectively. The Foundation has been classified as a publicly supported organization, which is not a private foundation.

The Foundation's tax filings are subject to audit by various taxing authorities. As of June 30, 2011 the Foundation is no longer subject to federal or state examination by tax authorities for years ended before 2007.

Concentration of Credit Risk - The Foundation maintains its cash and cash equivalents in commercial checking and money market accounts. The Foundation often maintains cash balances at its bank in excess of the federally insured maximum.

Subsequent Events - Subsequent events were evaluated through February 17, 2012, the date the financial statements were available to be issued.

NOTE 2 - RESTRICTIONS ON ASSETS

All permanently restricted funds held by the Foundation are included in the Los Altos Educational Foundation Endowment Fund (the Endowment Fund). This fund was established in 1997 by action of the Board of Directors for the purpose of providing a perpetual source of funds to support the Foundation's mission (see Note 1). Donor contributions to this fund are permanently restricted in accordance with the Endowment Fund Document.

NOTE 3 - LEASE

The Foundation has a facility lease agreement with the Los Altos School District. The operating lease has a 5 year term expiring in November 2011 with annual rent of \$2,754. Rental payment is included in the grant the Foundation (Tenant) makes near the end of each school year to the Los Altos School District
