EMERGENCY FOOD ASSISTANCE -

Lutheran Social Services of Alaska (LSSA) operates the Food Pantry in Anchorage, AK. In fiscal year 2011 the Food Pantry distributed 493,694 pounds of emergency food supplies to over 11,000 families or 31,607 individuals. The food distributed is a combination of government commodities, purchased food and donated food from the Food Bank of Alaska, retail stores, individuals and religious organizations.

EMERGENCY HOUSING SERVICES -

LSSA operates two housing units that benefit individuals that would otherwise be homeless. Our Roosevelt House provides safe and affordable housing for low income individuals with long term behavioral health issues and other medical problems. We served six fulltime tenants and 3 additional individuals for a four month period.

The Transitional Living Program (TLP) provides assistance and transitional housing for single homeless men. Our goal of the program is to break the cycle of homelessness and help the residents find sustainable employment and thus sustainable housing. Clients are required to have a job or secure one in the first 30 days of occupancy and are required to be free of all substance abuse. Residents also are required to share in household chores and yard work. In fiscal 2011 the program served 43 men.

DIRECT ASSISTANCE -

LSSA's Direct Assistance Program covers three main areas. First is Neighbor to Neighbor, where we offer assistance to individuals who are looking for work or are newly employed. In 2011 we assisted 1,909 individuals with help with bus passes, clothing vouchers, state ID's or driver's license, birth certificates, gas vouchers or prescription care. Our second area is medical transportation where we assisted 840 individuals with rides to and from medical or therapy appointments. The third area is assistance to stranded rural Alaskans who have found themselves stuck in Anchorage without transportation back to their rural village after being medevaced to Anchorage or having completed substance abuse treatment programs. We assisted 80 Alaskans with transportation home.
