low-income households paid significantly less in rent than they would have paid at market rates.

Reduced rental rates are made available based on several factors, including family income and

qualifications for various assistance programs. Households living in Housing Hope (and affiliate)

facilities totaled 324: 211 permanent units, 107 transitional units and 6 emergency shelter units.

SOCIAL SERVICES FOR HOMELESS FAMILIES: During the fiscal year ended June 30, 2011, 185 households

5,743 bed nights.
