The Child Development program provides school and after school care for approximately 505 low-income children in addition to firm, consistent and appropriate guidance in the development of social skills and one-to-one assistance with homework for afterschoolers.

The Head Start program provides comprehensive educational services for approximately 340 preschool children, health exams, dental care, nutritious meals, therapy for special needs children, parent education and social services for children who are economically or educationally disadvantaged.

The Mental Health program assists approximately 500 mentally ill adults who have gone off medication, are in denial, are unwilling to access the traditional system of mental health care, or who are living with caregivers and are at-risk because their living situation has becoming untenable. This program also offers refuge, support and companionship for persons struggling with mental illness & the attached social stigma.
